Fresh row as Musalia stops ODM bid to shuffle MPs in committees

ANC accuses ODM of dictatorship in proposing changes to various teams

Wrangles resurfaced again within NASA yesterday after Musalia Mudavadi's ANC blocked Raila Odinga's ODM party from removing its members from parliamentary committees.

Last week, Minority whip Junet Mohamed wrote to National Assembly Speaker Justin Muturi removing 16 MPs from different committees. The changes were rejected by mainly ANC which accused ODM of acting in a dictato-

Yesterday, ANC sought and obtained orders from the Political Parties Disputes Tribunal stopping the changes which were lined up for debate and approval by MPs.

The tribunal's deputy registrar Kyalo Mbobu directed the matter to be heard between the parties on Friday next week. Despite the order, Junet tabled the proposed changes in the House in the evening. The move was defended by Minority leader John Mbadi who said due process had been followed in arriving at the changes.

ANC parliamentary group chairman Ayub Savula (Lugari) protested, saying the changes were unprocedural. He said Standing Orders require that a member be given a hearing before he is removed from a committee and the reasons communicated to the Speaker.

The proposal will not stand. We have already filed a case in court and obtained orders. Those members are still validly in their committee," Savula said.

But Mbadi differed. "The motion has gone through the processes and has been approved procedurally. What ANC MPs are talking about is discharge of members from a committee. We were just reorganising

Alfred Sambu (Webuye East) was moved from Finance and National Planning to the Committee on the Implementation of the Constitution. He replaced Tom Kajwang' (Ruaraka) who was proposed to join PAC.

Christopher Omulele (Luanda) and Nyenze were appointed to the Finance and National Planning committee replacing Sambu and David Mboni (Kitui Rural).

Mboni was appointed to the Constitution Implementation Committee. Homa Bay Town MP Peter Kaluma was moved to the Committee on Administration and National Security replacing Justus Kizito (Shinyalu) who was moved to PIC alongside Homa Bay woman representative Gladys Wanga.

Gideon Mulyungi (Mwingi Central) was moved from PIC to Delegated Legislation Committee in place of Charles Gimose (Hamisi) and Abdulswamad Nassir (Mvita). Awendo's Walter Owino was appoined to the Members' Service and Facilities Committee taking over from Bungoma woman representative Catherine Wambilianga.

The list also includes James Mukwe (Kabuchai) who was appointed to the National Cohesion and Equal Opportunity committee in place of Mohammed Ali (Turkana East).

Loima MP Jeremiah Ekaimais was moved to the Trade committee replacing Timothy Wanyonyi (Westlands) who is to replace Mukwe in the NG-CDF committee.

Nasa also donated its position in the Agriculture and Livestock committee to Silvanus Osoro (South Mugirango) of the Kenya National Congress. His place in the Defense and Foreign Affairs committee was to be filled by Asha Hussein (Mom-

The changes evoke memories of the tussles over the committees earlier in the year. It is the second time Bunyasi is being drawn into a row over a committee. In December, he lost the chairmanship of PAC to Ugunja's Opiyo Wandayi (ODM) by 15 votes to three. ANC complained it had been shortchanged.

Similarly, Kalonzo Musyoka's Wiper fought tooth and nail for a slot on the Parliamentary Service Commission. It took the support of the Jubilee side for Borabu MP Ben Momanyi (Wiper) to eventually take the place of ODM nominee, Gladys Wanga.

DEWHIPPED

Wiper's Mulyungi and Bumnyasi had lost the race for the PIC chair to ODM's Abdulswamad Nassir.

ODM took up the majority of minority lots on House committees by virtue of its numerical strength in the alliance.

But the wrangles were not limited to the Opposition. In December, a bitter row erupted in the Jubilee Party after some MPs defied the party leadership to contest and win positions in four House commit-

Alfred Keter (Nandi Hills), Silas Tiren (Moiben), Kangogo Bowen (Marakwet East) and Alex Kosgey (Emgwen) sought court intervention after they were de-whipped.

But the party still went ahead to remove them from the committees through choreographed votes of no confidence after a meeting of the Parliamentary Group at State House. The meeting was called by President Uhuru Kenyatta.

Ethics and Anti-Corruption Commission made the claims ir affidavits presented to court.



Africa's youngest billionaire **Mohammed Dewji abducted**

Witness says kidnappers shot in the air to scare people away then fled with him

Africa's youngest billionaire Mohammed Dewji was abducted yesterday by armed gunmen from a hotel in Dar es Salaam.

According to mwananchi.co.tz, the youthful tycoon was kidnapped at around 5am from Collessium Hotel as he worked out in

Police officers in Dar es Salaam launched investigations into the alleged kidnapping.

Mwananchi.co.tz quoted an

Uber driver who said he witnessed the dawn kidnapping. The driver said the kidnappers shot in the air once to scare people away before whisking away Dewji to a waiting car, which sped towards Masaki.

"We were approaching the area when we saw four people alighting from a saloon car. Their faces were masked. They shot in the air once and the hotel's security guards scampered for safety," the

"They then got into the hotel and came out with someone whom I identified as Mohammed."

According to Forbes, Dewji has an estimated net worth of US\$1.54 billion (Sh154 billion), and is the 17th richest person in Africa. He is Africa's youngest billionaire.

Dewji was the first Tanzanian to be featured on the cover of Forbes Magazine in 2013 and has been featured on three separate occa-

He is the president and owner of MeTL Group, a Tanzanian conglomerate founded by his father in the 1970s. He is also a shareholder in the famous Simba Club in Dar es Salaam.

X ON matters traffic, is this now the normalised trend in Nairobi? Buses plying the Town-Ongata Rongai and CBD-Eastlands routes commonly known as manyanga or wire are defying all traffic rules. Besides overcharging in the rate of over Sh150 for a distance less than 20km, the buses disembark halfway the trip, are driven on pavements, overlap and ferry excess passengers. This happens in the full glare of traffic cops who man those routes. Is this another tragedy in waiting for the police bosses and NTSA to issue a statement and record statistics?

No one will be spared in investigating crash

Traffic police who let overloaded bus pass to be severely punished

Director of Public Prosecutions Noordin Haji last night ordered a thorough investigation into the Kericho bus tragedy to determine who was responsible for the 58 deaths.

He said the investigation will cover all government agencies charged with ensuring road safety, as well as vehicle owners. Haji said it would determine "the persons who may have, through acts of commission or omission, contributed either directly or indirectly" to the deaths on Wednesday.

Inspector General of Police Joseph Boinnet yesterday said traffic police manning the route of the overloaded bus will be severely punished.

Boinnet said investigations were underway into the the Fort Ternan accident and officers who let the bus pass will be disciplined.

"I am finding out who was on duty. I want to take to task any officer who allowed that bus to continue with the journey with all those

The Home Boyz bus was overloaded with 71 passengers instead of 62, it had no night travel permit and was speeding when elderly driver lost control. The bus rolled several times, tumbling into a steep valley below the he Londiani-Muhoroni road.

The owner of the bus and the sacco manager were arraigned yesterday

Bus owner Cleophas Shimanyula and Benard Shitiabai, the manager of the Western Crossroads Express Sacco, appeared in a magistrate's court in Molo. They did no take a plea after police requested to detain them while they investigate.

The magistrate deferred the ruling on the application to today, saying he needed time to go through both parties' submissions.

National Transport and Safety Authority (NTSA) director general Francis Meja yesterday said the bus's poor body construction could have contributed to the many fatalities. The roof was ripped off as the bus rolled downhill.

Meja said more than 100,000 buses have substandard body construction because they were built before the authority drafted new construction standards.

The body work specifications came into effect on May 22, 2017, and there is a seven-year grace period for all PSVs to comply.

"For them to comply, the bodies must be completely stripped and

built afresh," Meja said. "However, in light of what we have seen and the continuous loss of life, we can revisit this," with a view to shortening the grace period, he said.

Many buses use lorry chassis and put the body on top.

The standards require all metal inside the bus to be smooth, without sharp edges, so passengers are not cut and injured during an accident.

They also require roll bars fitted inside the body, making it difficult for the canopy to collapse and protecting the heads of passengers.

Seats are supposed to be secured to the chassis, not the body. Doors are to be side enough to allow easy entry and exit.

A family from Navakholo constituency, which lost five members in the crash, is appealing for help from the government and well-wishers to fund the burial of their loved ones.

Joseph Munala, 60, lost his son Roston Munala, 33; his (Roston's) wife Catherine Mutonyi and their two daughters Levis Lomen (Class and Vera Ndiona. Munala also lost his granddaughter Asha Dalina.

His niece Jerusa Anyera is admitted at Moi Teaching and Referral Hospital with a broken spine.

The family was travelling aboard the Home Boyz bus for the burial of their grandmother, Pelinah Tsaboka, set for tomorrow.

"I became anxious when by 9am they had not arrived," Munala said, sobbing. He said that by 10am his brothers set off to Kericho after learning through the radio that a Kakamega-bound bus was involved a fatal accident in Kericho .

"When they got there, they called and informed us that Roston and his family had been killed," he said.

"I was speechless because Roston is the one who bought the cow we have slaughtered for the burial of his grandma and I did not know that he himself would need a funeral."

Munala and his wife Elemina described Roston as being "everything" to them and appealed to the government and well-wishers to help them give their family a decent send-off.

Roston is the second last born in a family of five sons and three daughters.

"We're overwhelmed by what I am seeing. The government must rein in vehicle owners who fail to obey traffic rules. How long shall we continue losing lives? I don't know how these bodies will come here and how they will look," Elemina said.

The mood was grave in Navangala village, Mukulusu sublocation in Shinyalu constituency. Villagers were mourning a young family — father, mother and five-year-old boy — who perished.

Caleb Mambili Mukoshi, 27, was travelling with his wife Lucy Kemunto, 26, and their son Zedekiah Ambani to attend the funeral of his uncle Jacob

Caleb's mother, Florah Luseno, said Caleb had called her while still in Nairobi to say he would be travelling with his whole family to attend the funeral. She was to expect them on Wednesday morning.

They never arrived.

Traffic police graft on route cause of road deaths

he Kericho crash is worse than a massacre. It was right to kick out National Transport and Safety Authority from our roads because their work was harassing motorists. They were doing nothing, but just rent-seeking. We have a fully-fledged traffic police department. But they must be vetted afresh. Concerning the recent fatal accident, the traffic department at Kakamega should be held responsible because this Public Service Vehicle should have undergone regular inspections throughout its route.

Since the driver was tired, having driven the bus from Kakamega to Nairobi, the transport committee will discuss and make recommendations about the number of drivers in a bus. We will ask our chairman and Pokot South MP David Pkosing, through the clerk, to invite the traffic department, NTSA, Transport and Interior cabinet secretaries to answer questions from MPs in regard to the Kericho crash.

We had recently invited Inspector General of Police Joseph Boinnet to appear before us over road accidents. He only sent representatives. This time, we will ensure all these people appear before us on this very sensitive matter. We have enough laws to deal with road accidents, the only problem is that they are not implemented. We have zero implementation of these important laws. The issue of speed limits and speed governors must be enforced to ensure it is 80-km per hour because we are dealing with human life. We should check on the vehicle capacity and ensure that it is adhered to. We need to conduct frequent inspections on the stability of vehicles on our roads. Going by this recent accident, I can say that the police are incapable of controlling road carnage. I think there should be mass transfers of traffic police officers annually to curb corruption. We want the department to be a

fully-fledged department of police like that of Directorate of Criminal Investigations. We want it to have a streamlined and clear chain of command so that movement of vehicles can be easily controlled.

I want to send my condolences to the bereaved families, but we must ensure, as a people, that we prevent further deaths.

Handshake journey will not be easy, but worth it – Uhuru, Raila

'I want to tell Kenyans that you should not be misled. Kenya will never achieve her true position in the world unless we come together; unless we unite', says President Uhuru

President Uhuru Kenyatta and ODM leader Raila Odinga yesterday warned Kenyans the handshake journey will not be smooth, but said it is worthwhile

The two emphasized that their newly found friendship would meet resistance and pitfalls along the way as it focuses on the country's posterity and not short-term political interests.

"As my brother Raila has said, let us get out of the tarmac road and take the one with thorns because that is the right one," Uhuru said.

The President said the handshake would unite the country and end tribal hatred so Kenyans do not turn against one another in every election. "We want a Kenya where people cast

their votes and go back to their businesses as they wait for results," the President said in Kikuyu.

He spoke yesterday during the burial of Kikuyu music maestro Joseph Kamaru at Muthithi Secondary School in Murang'a county.

"It cannot be that every five years, Kenyans have to relocate from their homes because they are afraid," he said. Uhuru told off critics of the handshake, saying it would spur development and end tribal hatred and animosity that has characterised the country's political landscape.

"I want to tell Kenyans that you should not be misled. You should not be misled by cheap politics. Kenya will never achieve her true position in the world unless we come together; unless we unite and bring our respective strengths together and unless we respect one another," Uhuru said.

Competitive politics must not mean animosity between people, communities or religions, the President said. Uhuru's remark was in sync with Raila's earlier speech when he addressed mourners, and who through his parables, warned that the road to Kenya's peace and stability would be a bumpy one.

Uhuru said his decision to work with the President was to ensure that Jubilee supporters also join their NASA counterparts in "the land of promise."

"We were heading to Canaan but when we reached River Jordan, we realised it was infested with crocodiles. We then retreated to build bridges so that both Jubilee and NASA can cross the river to Canaan," said the ODM party leader in reference to the building the bridges initiative. The ex-PM stressed that the handshake

assignment would be about finding lasting solutions to the country's underlying problems that have bred inter-community conflict for decades.

"This is about uniting Kenyans and not about 2022. The 2022 elections will come and go, but this is for the future and posterity," he said.

After weeks of heated debate and opposition to the referendum calls, Deputy President William Ruto last weekend made a U-turn and backed the plebiscite push in what appeared to be an effort to lower political temperatures.

Ruto rooted for the handshake, telling Uhuru that he now has his 'unqualified support' in his efforts to unite the country. "As mtu wako wa mkono [as your errand boy], I will make sure that we all work towards achieving our development goals," Ruto said.

There was a gridlock along the Kaharati–Kigumo road as fans continued to pour into the school for the event which President Uhuru Kenyatta, DP William Ruto and ODM chief Raila Odinga attended.

Also present were more than 20 MPs, governors and other dignitaries. Scores of musicians, most of who said they were mentored by Kamaru, attended the burial and led mourners in songs.

Kamaru's sister Catherine Muthoni, popularly known as Celina and who performed the majority of songs with his brother, got to meet the President. The President said she reminded him he would buy her and the band sodas when they performed for the first President Jomo Kenyatta at their Gatundu home.

"I told her since I got her sodas when she came to my home, she would be the one to get them for me now that I am in their home," Uhuru said. He said he had lost a friend in Kamaru that he had known since childhood.

"Even as we mourn him, we are here to celebrate his life and the God-given talent he used to teach us culture, unity and to praise God," the President said.

"We thank God for all he has achieved and for all those that have been mentored by him and are now using their talents to entertain."

Uhuru assured Kamaru's family that as the President and friend, he would meet them to discuss ways of ensuring his legacy does not fade away.

Ruto said the musician did everything with his whole heart and urged Kenyans to emulate him. He said he was born when Kamaru produced the song 'Ndari ya Mwarimu'.

Raila eulogised Kamaru as a musician who had united the entire country.

Equity worker to be charged with theft

Cabinet approves mid-term budget

PSCU/ The Cabinet yesterday approved the mediumterm budget for 2019–20 as it endorsed the establishment of the Eastern Africa Regional Roads Authorities Forum.

The Cabinet meeting was chaired by President Uhuru Kenyatta at State House.

Once established, EARRAF will provide a platform for the harmonisation of road infrastructure in East Africa, especially transnational roads in terms of design, standards and costing.

EARRAF will bring together agencies responsible

for the implementation and management of road infrastructure in the region such as Kenha, Kura, Kerra, the Kenya Roads Board in Kenya, Uganda National Roads Authority, Tanzania National Roads Agency, among others.

The first African Tourism Ministers meeting held early this month in Nairobi brought together 27 ministers and heads of delegations as well as other dignitaries.

UN World Tourism Organization secretary general Zurab Pololikashvili, a representative of the AU Commission chairman and the Global CEO and President of the Hilton Group Christopher Nassetta attended.

21 COUNTS DROPPED

Women accused of Shabaab link freed for lack of evidence

MALEMBA MKONGO/Three women accused of being members of al Shabaab have been acquitted for lack of evidence.

Ummulkhayr Sadri, Khadija Abubakar and Halima Adan were charged with 21 counts, including being members of al Shabaab and commissioning terror activities. They were charged in April 2015. They denied the allegations. Mombasa chief magistrate Evans Makori said the prosecution terribly failed to prove the charges against the accused.

Makori said the evidence given by the prosecution's witnesses was not enough to warrant a conviction. Makori said the prosecution failed to show how they concluded the women were on their way to Somali to join al Shabaab, considering no one is banned from travelling. The magistrate said the prosecution ought to have unmasked the faces behind the Somali-based contacts and calls.

'DIDN'T SEE THE CONTRACT'

MPs put procurement agency boss to task over tax system

GIDEON KETER /MPs yesterday expressed dissatisfaction in the vague manner in which Public Procurement Regulatory Authority handled the direct procurement of e-tax stamp system by KRA.

PPRA director general Maurice Juma said he was never given contract documents that led to Kenya Revenue Authority to opt for direct procurement of the Excise Goods Management System.

He spoke when he appeared before the National Assembly's Public Investment Committee at Parliament Buildings. "I have not seen the contract. What we were looking at was the process of procurement," he told the team chaired Mvita MP Abdulswamad Nassir. EGMS was supplied by Swiss firm SICPA Security Solutions SA Ltd at a cost of Sh17.7 billion. Juma told the committee if his authority will get more information that prove irregular award of the tender, then they will review the process.

354 UNAPPROVED OFFICERS

Kemsa on the spot over 'irregular' hiring

LUKE AWICH/Kenya Medical Supplies Authority is facing queries over unapproved hiring of 354 staff members gobbling up over Sh695 million annually in salaries.

Auditor General Edward Ouko in his 2016-17 report questioned the excess hiring, which he said is irregular and unnecessary. The medical agency, the report says, is only approved to hire 341 officers, not the current 695 employees on its payroll. "That authority has 695 employees against the approved establishment of 341, resulting to unapproved over-employment of 354 officers. No explanation has been provided for the excess employment," Ouko's report noted.

In the year under review, the report points out that the medical agency spent Sh25 million to pay 47 officers who were employed and eight who were promoted.

The report, however, indicates there was no supporting documentation to back the promotion claims.

Appearing before the National Assembly's Public Accounts Committee, chaired by Mvita MP Abdulswamad Nassir last month, Kemsa CEO Jonah Manjari said the extra staff is a combination of Kemsa staff and programme officers. He defended the decision not to attach supporting documents of those employed and promoted, citing sensitivity and bulkiness of the documentation.

Manjari said 366 programme officers were contracted to render services to the various programmes the agency is running with other strategic partners.

Kassaine freed, ordered to report to DCI on Thursdays

He lent his gun to Jowie, main suspect in Monica Kimani's murder in Kilimani

Businessman Brian Kassaine who lent a pistol that the prime suspect in the gruesome murder of Monica Kimani in Kilimani used to shoot himself, has been set free by the police.

After 13 days in custody, the Lang'ata businessman was allowed to go on condition he reports to the DCI headquarters every Thursday for the next two months.

Police sources yesterday said Kassaine will most likely throw his friend Joseph Irungu, alias Jowie, under the bus.

Irungu is the fiance of Citizen TV reporter Jacque Maribe and the prime suspect in the September 19 murder of Monica.

Monica was a budding businesswoman, who had only hours earlier arrived from Juba, South Sudan. She was to travel to Dubai.

Investigations officer Maxwell Otieno said Kassaine is still being treated as a key suspect.

Maribe and Irungu will be presented in court on Monday after they were ordered remanded. This was to allow Maribe to take a mandatory mental test.

Detectives investigating the matter applied to have Kassaine released on condition he reports twice a week as they probe the murder.

But the suspect, through his lawyer Kefa Ojijo, objected to the application, arguing that he should be released without any condition.

Lawyer Ojijo told Kiambu principal magistrate Justus Kituku his

client was innocent and had no links to the murder.

But Kituku ordered Kassaine to appear before the DCI every Thursday for next two months.

He has also directed him to deposit his passport with the police within 48 hours. "...failure to comply with the orders, the police will be at liberty to seek warrant of arrest on the same," the magistrate said.

On his arrest, Kassaine told police Irungu shot himself in a botched suicide attempt. He said that Irungu had on September 11 borrowed his Ceska pistol for "training", but the gun had no bullets.

Kassaine said he was at his Royal Park estate house in Lang'ata on September 21 when he was woken up at around midnight by someone knocking his gate. KASSAINE IS STILL BEING TREATED AS A KEY SUSPECT WHO AUTHORISED?

Kazungu, Wakhungu car allowance query

JAMES MURIMI/Water PS Joseph Irungu was yesterday put to task by MPs to explain who authorised irregular payment of Sh7 million car allowance to former CS Judi Wakhungu.

The National Assembly Public Accounts Committee asked Irungu to explain why the payment was done contrary to a presidential circular that set the upper limit of car allowances for CSs at Sh2 million.

Irungu told the team, chaired by Ugunja MP Opiyo Wandayi, that the circular had directed State departments to withhold Sh2.1 million tax and remit it to Kenya Revenue Authority.

Last week, the committee heard from Mining PS John Omenge that former Mining CS Dan Kazungu also acquired Sh7 million car allowance. Omenge said he was not sure whether Kazungu spent the cash in purchasing the vehicle.

The committee heard the two CSs have not remitted Sh2.1 million taxes as required by the circular of July 7, 2011, from former Head of Public Service Francis Muthaura.

Water CS Simon Chelugui has appealed to Foreign Affairs CS Monica Juma to assist in recovering the Sh2.1 million from Wakhungu.

Kimemia calls for EACC audit of staff to remove ghost workers

Governor says unaccounted for employees are drawing millions from county every year

Nyandarua governor Francis Kimemia has invited the Ethics and Anti-Corruption Commission to audit employees to get rid of ghost workers.

Kimemia yesterday said he was concerned that ghost workers were drawing millions in salary from the county coffers. He said they were employed by the previous administration.

An audit conducted last year did not resolve the problem because the county was still losing millions to ghost workers, he said. "The audit instead ended up proposing that we employ more workers despite the high wage bill," Kimemia said.

The governor said he was also concerned with the high number of stalled projects. The projects were initiated by predecessor Daniel Waithaka's administration.

"We have genuine contractors seeking their payment and we shall pay them but we also want the EACC to investigate those contractors who were paid yet their projects were not completed," Kimemia said.

He was speaking during a workshop for senior county officers in Naivasha. The two-day workshop was organised by EACC.

Kimemia dismissed the EACC rankings that placed the county 16th on the list of regions with he most corruption cases.

"There was a survey sponsored by World Bank that placed Nyandarua

second in terms of service delivery and we are committed to fighting the vice," the governor said.

Kimemia asked the EACC and the DPP to probe claims that billions of ill-gotten wealth was stashed in offshore accounts. There were claims that as much as Sh14 trillion could be stashed in tax havens. He asked his officers to improve services.

"As the top leadership of Nyan-

darua county, we should make sure that the few resources from the national government reach the common mwananchi through improved services," he said.

EACC manager for Central Rift Charles Rasugu said the health department was the most corrupt in Nyandarua. His claim was based on a recent survey. The report said the number of people who pay bribes to get services rose from 46 per cent to 62.2 per cent in one year.

Rasugu said complaints included embezzlement, bribery, abuse of office, fraud, irregular recruitment and procurement malpractices.

"From 2013 to date, the commission has received over 115 complaints from Nyandarua county. Some of them have been taken up for investigations," Rasugu said.

Ex-cop in court to block arrest over sexual assault allegation

Dickson Ndemo says DPP is being pushed to have him charged to settle scores

SUSAN MUHINDI/ A former police officer has moved to court to block his prosecution over an alleged sexual assault on a minor.

Dickson Ndemo has accused a senior cop stationed at Jogoo House in Nairobi of using his powers to have him prosecuted to settle scores.

The minor is the daughter of the senior officer. In his affidavit, Ndemo said his prosecution was hatched and orchestrated by the parent of the minor.

In 2015, Ndemo was investigated by the officer in charge of Shauri Moyo police station over the allegations. It was concluded that he was not culpable and cleared of the allegations.

At that time, he was living at the Shauri Moyo police quarters before joining the Kajiado county assembly.

"The investigations were anchored on a malicious complaint of the said minor on the prompting of her father who had a bone to pick with me. The resultant report clearly exonerated me," Ndemo says.

His file was forwarded to the DPP who said there was no evidence to have him charged.

The DPP wrote the recommendation to the Shauri Moyo police

station

Ndemo says the minor's father was infuriated with the report and commenced a unilateral process leading to reopening of the file for "purported fresh investigations to lead to a predetermined conclusion".

He said the reopening of the file was triggered by malice and ulterior motives which amount to unfair administrative action.

"I have reliably learned that the DPP and DCI have issued warrants of arrest against me on the strength of a complaint lodged by the said father of the minor," Ndemo says.

He says the threat to arrest, detain, charge and prosecute him is real and that it will jeopardise him.

He wants the court to quash the DPP's directive to arrest, charge or prosecute him on allegations of indecent act against a minor. Ndemo also wants an order barring the DPP and DCI from arresting, detaining, charging him on allegation of indecent acts with a child.

Ndemo said the DPP is being pushed by the department of police to have him charged.

"The two state organs are acting on mere suspicion based on a one-sided story," Ndemo said.

SENATE PROBE

Court declines to stop Ruaraka land probe summonses

SUSAN MUHINDI/ The High Court has declined to bar senators from summoning directors of two firms mentioned in the controversial Ruaraka land deal.

Justice John Mativo yesterday said the decision to invite Afrison and Hueland Limited can only be quashed if the Public Accounts and Investments Committee exceeded its

Mativo said the invitation to appear before the committee was legal and the court would be acting unconstitutionally if it stopped the summonses.

"The objective of monitoring state officials to guard against corruption in public office forms part of the constitutional imperative to combat corruption and ensure transparency and accountability and prudent use of state resources." Mativo said.

The application was filed by the two firms.

Shopkeeper charged with putting poison in employer's syrup

Ann Wanjohi on Friday discovered her syrup had turned a suspicious colour after it was diluted. The regimen had been prescribed by a Nairobi clinic. It was confirmed to have contained a poisonous substance upon examination at the clinic. It was not identified.

CCTV footage showed Wanjohi's employee Sharon Otieno picked the syrup from her boss's handbag and retreated to the lavatory. Sharon, 22, was charged at the Milimani Law Courts with poisoning Wanjohi at Kariokor market.

She denied the charge before chief magistrate Francis Andayi and was released on a Sh50,000 cash bail or an alternative bond of Sh500,000. Hearing was set for November 21.

SHOWS MOVEMENT OF RADIO

Video evidence presented in Willie Kimani murder trial

For third consecutive day, Kennedy Mwadime continued with his testimony





The High Court was yesterday shown video evidence of how a radio phone belonging to the key suspect in human rights lawyer Willie Kimani's murder moved on the specific date.

For the third consecutive day, Kennedy Mwadime continued with his testimony that seeks to link the murder suspects to the killing of Kimani, his client Josephat Mwenda and taxi driver Joseph Muiruri.

The radio phone under scrutiny is believed to have been with Fredrick Leliman who is charged alongside Leonard Maina, Stephen Chebulet, Sylvia Wanjiku and police informer Peter Ngugi.

PREVIEW

Mwadime further explained to the court how police radios are tracked at the Integrated Command Centre.

The witness told trial judge Jessie Lesiit he was tasked to retrieve movement data of all radios used within Mlolongo and Athi River area.

According to him, nine radios had been assigned, apart from one radio which had been installed in a vehicle, the others were used as hand phones.

"We did a quick preview to confirm whether they were acting on the network within the specific dates and times," the witness said.

The court also heard that it is after a further preview they confirmed the radio had a lot of movements

FREQUENCY

Mwadime said the investigations showed the radio was at Syokimau Police Post on June 23, between 12.20 min and 12.40pm.

This is the same time prosecution believe Willie Kimani, his client Mwenda and driver were abducted and later killed.

The radio's frequency was also captured within Mlolongo police



station between 3.20pm and 3.40 and it was later at Syokimau police station between 6.40pm and 7pm.

The expert also established that the same radio was at an isolated field within Soweto area between 7.40pm and 8pm the same day.

Mwadime said that the investigating officer wanted to find out if there was any radio that registered activity within Mavoko law court, particularly at 12pm.

He said that the same gadget was later traced along Eastern bypass and minutes later on Thika Superhighway at 12.40pm.

The prosecution believes the three men were abducted, held for hours at Syokimau police post and later killed at an open field within Mlolongo.

Their bodies were later found at Oldonyo Sabuk River stashed in gunny bags.

Oilibya boss blocks Sh1.5m buglary trial

JOSEPHNDUNDA/ Oilibya Kenya general manager Duncan Murashiki has obtained interim orders restraining the DPP Noordin Hanji from prosecuting him over burglary and theft of Sh1.5 million property at a petrol station last year.

Murashiki, a Zimbambwean, is charged alongside four colleagues Nancy Kwinga (retail manager), Joyce Wanjala (territorial manager), Antony Mugo and Stanley Marete.

On June 3, the DPP directed that they be prosecuted over burglary, theft and and malicious damage to property after invading a petrol station in Juja in July last year.

Charges against them state that they stole 10 units of CCTV system cameras valued at Sh400,000, a digital video recorder 16 channels worth Sh200,000, gas cylinders valued at Sh200,000, lubricants worth Sh500,000, car wash vacuum cleaner worth Sh30,000 and fuel worth Sh200,000 all valued at Sh1,530,000, the property of Maced Limited. They also face a charge of unlawfully damaging five padlocks valued at Sh12,500.

But they moved to court to challenge the directive and suspend their prosecution.

Radiographers to get specialised training

CHARLES MGHENYI/ About 90 per cent of the 1,400 radiographers in Kenya lack specialised training, an association has said.

The Society of Radiography on Wednesday urged the medical officers to undergo further training so they can be certified. President Kenneth Kariuki said the recent upsurge in radiography equipment and an upward shift in technology has widened the training gap among radiographers.

To improve efficiency, there is need to improve radiographic equipment handling techniques, he told the press at the bi–annual Radiographers' Scientific Conference in Mombasa. Kariuki announced a two–year partnership deal with GE Healthcare to train at least 140 radiographers on the latest medical imaging technologies and techniques.

HIGH RETAIL PRICES

Fix loopholes in drugs supply chain, board told

PATRICK VIDIJA/ The Kenya Association of Pharmaceutical Industry yesterday appealed to the Pharmacy and Poisons Board to swiftly fix gaps in the drug supply chain.

It said manufacturers have had to take responsibilities for poor quality of drugs reaching patients. KAPI chairperson Anastacia Nyalita said a lot of gaps within the supply chain need an urgent attention if the government intends to ensure Kenyans have access to quality and affordable medicines.

Nyalita spoke during the launch of Medsource — a private entity seeking to promote access to affordable medication. Pharmacy and Poisons Board registrar Fred Siyoi rsaid they have made strides to regulate the safety and quality of drugs, but will look at the loopholes.





SEEKS HELP FROM WANANCHI

Global warming a threat to Big 4 agenda — Tobiko

WANT MARKET FORCES TO PREVAIL

Millers oppose fixed, controlled unga price

Government directed that 2kg packet be sold for not more than Sh75; many retailers have complied





Millers are against the government's decision to fix the price of a 2kg packet of maize flour.

Agriculture CS ordered that it be sold for Sh75. But the millers want the market forces to prevail. He said any trader selling the flour at more than Sh75 would be arrested for exploiting consumers.

Early last month, millers had indicated they would increase the price by Sh4 to cater for the increase in fuel tax. Yesterday, Cereal Millers Association CEO Paloma Fernades said the government should let market forces to regulate the retail price.

"Price fixing is bad for the industry. It causes distortion in a market that is very competitive. When there is a lot of maize, as it is now owing to a bumper harvest, the prices of maize and unga will automatically go down," she said.

She attended release of a report on the cost of production for maize, irish potatoes and rice in Kenya by Tegemeo Institute in Nairobi.

By yesterday, millers had given in to the pressure by government agencies to reduce the retail price. At city supermarkets, a spot check by the Star revealed that Soko and Jogoo brands are selling at Sh75 and Kifaru at Sh71. Some millers told the Star that by last week, some retailers threatened to return stocks they had if millers did not reduce prices as per the government's directive.

The retailers said the authorities, especially Nairobi county officers, intimidated and warned that their licences would be cancelled.

President Uhuru Kenyatta had urged millers to reduce the price to Sh75. He said there was a surplus of maize. "This year, the country will have a stock of 56 million bags against an annual consumption of 52 million, meaning a surplus of four million bags," he said.

He spoke after Nairobi governor Mike Sonko warned that the county would withdraw licences for retailers selling above Sh75. Sonko asked Uhuru to allow the city askaris to crackdown on such traders.

Yesterday, Tegemeo Institute director Milton Ayieko said price control and fixing can distort the market and raise the consumer price.

"Price fixing distorts the market and doesn't allow the forces of demand and supply to play out to move the produce to where it is intended for consumption," he said. L: Cereal Millers Association CEO Paloma Fernandes at a CMA briefing in Nairobi on June 22 /ENOS TECHE

Wildlife traffickers' assets to be seized

UK is funding new initiative that will benefit Kenya

The bank accounts of wildlife traffickers and criminal gangs will be frozen and their assets seized.

Their visas will also be revoked under a new initiative by the UK.

Money launderers and tax evaders will be pursued in the latest efforts aimed at disrupting criminal networks and targetting individual basses

This has been made possible after UK's International Development Secretary Penny Mordaunt announced a new joint initiative with the Foreign Office, to target wildlife traffickers and criminal gangs and tackle the global scourge of the illegal wildlife trade.

Under the new initiative, many countries, including Kenya, will benefit from funding of £3 million (Sh395 million) from the DFID.

The funds will come from a mix of new money and allocations from pre-existing budgets, and £0.5million from the Foreign Office.

This money will be allocated equally between the United Nations

Office on Drugs and Crime and the Egmont Group, through the Egmont Centre of FIU Excellence and Leadershin

Mordaunt said, "We can only stop the illegal wildlife trade by targetting the international gangs and criminal networks, which essentially drive it."

UKAid is directly supporting efforts to recover illegal assets, disrupt organised crime networks and stop the flow of dirty money to protect endangered and trafficked species.

"The illegal wildlife trade is driving endangered species on the brink of extinction and robbing communities around the world of vital income. To truly end this crime we need to tackle corruption, which allows the trade to flourish," Foreign Secretary Jeremy Hunt said.

UK-funded Global Wildlife Programme worked with Kenya's Parliament to enact the Wildlife Conservation and Management Act 2013, which increased both prison sentences and financial penalties for wildlife-related crimes. A landmark illegal wildlife trade conference is being held in London, attended by First Lady Margaret Kenyatta.

Throughout his tenure as CEO of the Kenya Film and Classification Board, Ezekiel Mutua has courted controversy. The man with a moustache and thick, properly combed hair is weeks away from finishing his term, but Kenyans will not forget him in a hurry.

There are those who have seen him as a moral police. Others as a man punching above his weight. And others still as a petty man obsessed with himself and craving publicity to stay relevant.

Mutua, whose term elapses early next month, is keeping his fingers crossed. His continued stay at the helm will be determined by a new board, against opposition from a section of the public who feel he is trying to babysit them, and from filmmakers who accuse him of strangling their trade.

But biting more than he can chew is not new to the man. Back in 2008, when he was the Information director at the then Information ministry, Mutua threatened to disband the Media Council of Kenya for what he claimed was playing with government.

The council had formed a team to audit how journalists had covered the 2007 general elections, which angered him. He reacted with the hope that his actions would endear him to then President Mwai Kibaki, who was commencing his second term after protracted and violent polls.

To journalists, Mutua invokes memories of their 'stolen' television sets.

Before 2006, when he was the Kenya Union of Journalists secretary general, Mutua was a defender and friend of scribes. He started transforming himself to a foe when he bungled the 2006 media awards, by failing to deliver the prize money and televisions sets to winners.

BANNING SPREE

In 2017, he kicked off a storm by banning billboards and broadcast advertisements with strong sexual, alcohol, gambling and violence appeal.

Also in his blacklist were betting adverts, witchdoctor posters, as well political commercials that demean politicians and their parties and manifestos, and those that strengthen stereotypes. He warned broadcasters who did not toe the line of dire sanctions.

The ultimatum drew the wrath of the Communications Authority of Kenya. CAK director general Francis Wangusi dismissed the board as having no powers to issue such demands to police broadcasters on the programming code.

Mutua was not deterred. In his next sensational act, the self-styled anti-gay crusader posted a photo on Facebook, posing with his passport and visa in September 2016.

"Because of my moral values, including the banning of content promoting LGBT and atheist culture in Kenya, someone wrote in a local daily that I will never get a visa to the USA," he wrote.

"I not only got it but it came on a diplomatic passport and I didn't even have to go to the Embassy for biometrics or pay the visa applications fee. It was delivered to my office free of charge thanks to our efficient Foreign Affairs ministry and highly courteous US Embassy officials. America, here we come. To God be the glory."

The stunt ended up sparking a diplomatic row pitting him against the Immigration department, who ordered him to surrender the travel documents upon entry in Kenya, as he was not qualified to hold a diplomatic passport. Mutua ate humble pie.

This year he's caused a stir after banning safe abortion promotion and lately the 'Rafiki' lesbian love film.

'HUNGRY FOR POWER'

Bloggers Association of Kenya chairman Kennedy Kachwanya describes Mutua as a man hungry to exercise powers that don't exist in his purview.

"We can say the man is passionate about his work. Unfortunately he behaves like a tethered man in a small room whereas he wants to roam free, making him act and overstep his mandate in almost all the occasions," Kachwanya said.

"His mandate is strictly to classify films. It means all he is supposed to do is categorise a film as suitable for under-16 or those above 18 years or whether it should be aired at night or during the day. But he does less of that and has concentrated on playing Kenya Film Classification board CEO Ezekiel Mutua address the press at Uchumi house on Tuesday, April 19 on the release of new advertising content classification guidelines //COLLINS KWEYU

to the gallery, banning this and that in the name of morals."

The bloggers' head said the creative industry needs free space to operate, accusing Mutua of gagging artistes and, thus, scuttling any efforts to grow.

"He seems to be a sadist, too. For instance, he celebrated when Rafiki, a Kenyan-produced film, missed out on the Oscars. Who does that?" Kachwanya asked.

Blue Sky Films managing director Jim Shamoon said Mutua is hardworking and results-oriented, though he lacks objectivity in executing his


Without a gazette notice or presidential executive order, he took over licensing of films, and this has seen

reluctance by producers to submit their work for licensing, Shamoon said, adding that Mutua also insists on classifying scripts before the films are made.

"His purist approach has discouraged producers and led to cancellation of big international film production deals. Kenya has become hostile to

the film industry because of this increasing censorship," Shamoon said, adding that Mutua has had a polarising effect on the sector.

"In his agenda, he left out those perceived as upmarket producers and those who bring in big film business. He engaged more slum and smalltime producers, which he regards as the only stakeholders, which is populist. He should instead involve every player and focus on the business model of film industry," he added.

During last year's Oscar Awards, a source who travelled to the US told the Star that Mutua had travelled for the annual ceremony, though he was blocked from attending because he had no invite.

"This is the time I realised the man preaches water and takes wine. He took some of us to Las Vegas. This is a sin city headquarters of gambling and orgies. His choice baffled every one of us, because on landing, he put on the moral lenses," the source said. In May this year, Mutua had a first-

class ticket and a full six-star hotel booking to attend the world's prestigious annual Cannes Film Festival. Unfortunately he never accessed any of the venue areas because he had not been invited. Last year, together with the then Culture and Arts CS, he attended the festival amid accusations of joyriding.

Two Kenyan actors of 'Neophobia' film, which had been picked for screening, missed out on the event because of lack of facilitation. They accused Mutua of getting free trips off their work

In his defence, Mutua said: "I travel everyday in my own capacity as CEO of KFCB. I don't need to have anybody's film to travel. My travel just like other top government officials is cleared by State House, and you will never be cleared to go and joyride."

At the office, he is known as a headmaster, who polices any staff who seems to challenge him or have alternative viewpoints.

"He is a know-it-all boss. His word is gospel. Those who don't sing his songs are isolated and humiliated," a staff said.

'PROFESSIONALISED FILM'

In Mwaniki Mageria, the secretary general of Riverwood, Mutua has a supporter. One who believes Mutua is the right man for the job and who performed well.

"Prior to his appointment, little or nothing was heard about film. But as the CEO, he elevated the discussions that have helped bring conversations on film to the national debate," Mageria said.

He helped enforce regulation in the film industry, setting out operation parameters. "Initially we worked in a free market, where everything goes. But his regulation has helped grow the sector by improving content quality, enabling us to compete effectively and professionalising the sector," he said.

Mageria said it was false to accuse Mutua of overstepping his mandate, saying if that was the case, then he could have been sued for it.

"Our freedom of expression had started eroding our moral fabric. Popularity was slowly overtaking humanity, and some of us were aping or becoming so receptive to rogue or alien lifestyles away from how we were brought up," Mageria said.

"But someone had to remind us of our value system and call it out as it is, and that person was Mutua."

Mutua on his part said he has lived up to his job's calling, performed beyond expectations and has no apologies for his actions.

"I'd rather be accused of overzealousness than lethargy. I have raised the profile of KFCB. In just three years, everyone knows the organisation. I tripled its revenues from Sh88 million annually that I got when I came here. I have also built partnership across, whose value is way beyond Sh2 billion," Mutua said.

His stand on films, he said, is informed by the desire to have productions that promote values like historical heritage, hard work, honesty and a just society.

"We are what we consume. If we allow the country to consume violence then we will remain a conflict-prone country," he said.

"If it's easy life and shortcuts, then we will breed a society that depends on tokenisms and thrives on sponsor's notion." STOP THE CUT

On Girl Child Day, youths call to end medicalised FGM

Campaigners, political leaders and NGOs signed an open letter to the Anti–FGM Board Chief Executive Officer Bernadette Loloju, which calls on the government to increase disciplinary measures on medical professionals who cut girls.

Youth activist Sadia Hussein delivered the letter to Loloju in person to ensure the youth's rallying cry is heard ahead of the UN's International Day of the Girl. Each year, this day provides a platform to raise awareness of the unique challenges girls face globally and promote the fulfilment of their human rights.

"We are raising our voices and making a stand to end FGM for our sisters and future daughters," the youth say in their letter. "Will you join us?" they ask Loloju.

Leading the charge was Sadia Hussein, Kenyan youth campaigner, who said: "We applaud our government's commitment to ending FGM in recent years. Yet it is unacceptable that FGM is still being practised by some medical professionals in Kenya. We are urging the government to increase disciplinary actions on those individuals that cut girls. We have spoken — will you join us?"

The activists are part of the Youth End FGM movement, a grassroots campaign that has made waves across the African continent and worldwide in recent months. The campaign has seen thousands of young Africans pledge to make theirs the generation that ends FGM by launching a global social media campaign — #IHaveSpoken — that breaks the silence that allows the harmful practice to prevail.

SEVEN MILLION REACHED

The Youth End FGM campaign has already reached over seven million people online alone and has secured the support of celebrities and influencers across the continent. Now campaigners hope their collective clout will encourage decision—makers to help them make their goal of ending FGM a reality by bringing about meaningful, long–lasting change at government level.

The campaign is being supported by The Girl Generation, the world's largest Africa–led global collective of partners, brought together by a shared vision that FGM can—and must—end in this generation.

Dr Faith Mwangi–Powell, global director for The Girl Generation, said: "On such an important day like today, where we come together to empower girls around the world, it is inspiring to see such passionate young people directly engaging with leaders.

"I sincerely hope Mrs Loloju will heed their call of increasing disciplinary measures on medical professionals who cut girls. In doing so, she will be taking a huge leap forward in making the world a place that is safer for our girls."

Machines will not completely phase out humans – 2019 World Bank report

MERCY GAKII / Ability to learn will determine whether one will be employable as the changing nature of work affects the world, according to the 2019 World Development

Contrary to the largely held notion that technology will kick people out of work has been trashed by this report that indicates both machines and human effort will augment one another for successful outcomes.

"Advanced cognitive skills, such as complex reasoning when combined with machine capabilities drive innovation," commented the blog on the report.

The report indicates that artificial intelligence will help in solving complex problems and take new ideas to scale, through combining human advanced cognitive skills and machine capabilities. Some areas where Al and human skills are put to use together include medical diagnostics, cyber security among others

With 500,000 to 800,000 young Kenyans entering the job market each year, the economy has not been able to provide the necessary amount of employment opportunities, formal and informal alike, according to a 2017 report on youth employment in Kenya by British Council. Economic progress has primarily benefitted the older generation. It says that young females in rural locations constitute the largest share of unemployed Kenyan youth, while their counterparts in urban areas are most likely to be unemployed, with gender and living location picked out as the defining factors, but youth unemployment remains rampant throughout the country.

The report emphasizes social emotional intelligence, including teamwork abilities and conflict resolution which when combined with AI can quickly identify highly customized interventions for clients.

"When machines assist insurance agents in evaluating injury reports, these agents have more time to apply the human skill of empathy to more humanely deal with customers," the report reads in part.

At the same time, technology is creating opportunities, paving the way for new and altered jobs, increasing productivity, and improving the delivery of public services. When we consider the scope of the challenge to prepare for the future of work, it is important to understand that many children currently in primary school will work in jobs as adults that do not even exist today. The report emphasises the importance of paying attention to continual learning in order to stay ahead of innovations.

Many jobs today, and many more in the near future, will require specific skills including a combination of technological know-how, problemsolving, and critical thinking-as well as soft skills such as perseverance, collaboration, and empathy.

CMA seeks foreign currency use for bond purchase

CYNTHIA ILAKO /Kenya is planning to allow the use of foreign currencies in the local bond market, a Capital Markets Authority official has said.

This will not only boost uptake of products offered at the Nairobi Securities Exchange by foreign investors, but may create a leeway for Kenyans living abroad to invest in the capital markets with much more ease.

Products offered at the NSE are currently only offered in Kenyan Shillings.

"When you issue, say, a Dollar denominated bond, you will expect more than 78 per cent will be foreign investors so we are looking at attracting foreign capital," assistant manager for strategy and policy at CMA Jairus Muaka said.

During a policy roundtable forum held yesterday, Muaka said the proposal to have foreigners trade with local bonds using their home currency was introduced in November last year and was still being reviewed by the Central Bank of Kenya to fully understand its impact to the economy.

"Central Bank is still reviewing what impact adjusting the payment system to accommodate foreign currencies will have on the shilling and in turn on the country's economy," Muaka said, adding that the government's fiscal agent was not opposed to the idea.

CMA data shows the bond market has registered a turnover of Sh444.54 billion in the year to September 2018.

Muaka said the capital markets' regulator has already received proposals from Afrexim Bank and IFC to issue dollar denominated bonds and engagements are still ongoing.

According to CMA's second quarter soundness report, Treasury bonds account for 99.88 per cent of Kenya's total bond market leaving corporate bonds at a low 0.12 per

Maize farmers penniless as ugali lovers pile plates

Cost of production does not match the current market price

The year 2018 has been good for ugali lovers but bad for Kenya's maize farmers, a researcher has said.

It is even getting better for consumers, as the price of a 2kg packet of unga is currently retailing at Sh75, following a government's directive to reduce the price due to surplus of maize in the country.

However, Timothy Njagi, a research fellow at the Tegemeo Institute said that while the consumers are paying less for a plate of ugali, maize farmers are extremely broke.

He said despite the cost of producing a 90kg bag of maize dropping from Sh2,083 last year to Sh1,781 this year, farmers re still making losses of up to Sh531 per bag as

the same bag of maize is retailing at Sh1,250.

He was speaking yesterday in Nairobi during the release of a report on the cost of production for maize, irish potatoes and rice in Kenya by the Tegemeo Institute.

"The country has enough maize stock to sustain the country until July 2019 but farmers are extremely broke and not making money. This is a bad year for the maize farmer in Kenya but a good one for the consumer," he said.

Njagi attributed this to delayed payments by the National Cereals and Produce Board to farmers who sold maize to the government last year, and low market prices.

The delay has angered some farmers from the North Rift and they are now turning their maize produce into animal feeds. Some farmers have also reduced their acreage

under maize production with one farmer from Uasin Gishu only having 79 acres under maize this year compared to 210 acres in 2014/2015 crop year.

"The increasing production has triggered maize prices to a down ward trend thus leading to huge losses to the farmers. Over and above local production, there is also a lot of maize import coming from Uganda and Tanzania," said Njagi.

Lilian Kirimi a senior research fellow at the institute said that the country is set to have a bumper harvest of 46 million bags which will last until July 2019.

She said the current maize stock is at 20.1 million bags with farmers holding 15.8 million bags, millers and traders have 383, 612 bags while NCPB has 3.8 million bags. Bean stock is at 4.9 million while wheat is at 4.7 million bags.

Workd Bank revises Kenya's growth rate

The forecast is largely consistent with that issued in April 2018

VICTOR AMADALA /The World Bank has revised Kenya's 2018 economic growth from the 5.5 per cent figure it issued in April to 5.7 per cent.

It attributed the change to improved agricultural yields on account of good rains, better business environment and easing of political uncertainty.

"Real GDP growth is projected to reach 5.7 per cent in 2018, an upward revision of 0.2 percentage points from April," the Kenya Economic Update report stated.

Steady private sector growth marked with increased imports of raw materials and positive investor sentiment had seen the Purchasing Managers' Index (PMI) remain in expansionary territory of above 50 points. The growth is projected to remain robust over the medium term with GDP growth projected at 5.8 per cent in 2019 and 6.0 per cent

The growth would have been much higher were it not for the current slack in the economy.

The medium term output gap is expected to narrow due to recovery in agriculture and growth in demand. External balance position is expected to remain favourable, thereby supporting macroeconomic stability.

"This forecast remains largely consistent with those in the April 2018 Economic Update, with a slight downward revision of 0.1 percentage points for 2019 and 2020," World Bank said.

It however warned that subdued growth in private sector credit, a re-

currence of adverse drought shocks, and fiscal slippages leading to macroeconomic instability could dampen growth prospects.

It advised Kenya to review interest rate capping law, saying it has tightened liquidity flow to small businesses that drive the economy.

Kenya capped commercial lending rates at four per cent above the Central Bank Rate (CBR) in 2016.

Banks are currently lending at not more than 13 per cent.

On the external front, the Washington based lender said that an unanticipated spike in oil prices, uncertainty and rising trade tensions, and unanticipated tightening of global financial market may result in reversal of capital flows from emerging and frontier markets, including

ELIZABETH KIVUVA / Kenyans own a mere 20 per cent of the real estate developments in Nairobi, a women's investment forum was told yesterday.

According to property development firm, Optiven, Nairobi has seen an increase of foreigners investing in real estate and hotels.

Chief executive George Wachiuri said local developers need to tap into the widening middle class in the metropolitan area and an increased GDP per capita income.

Speaking at the Women Entrepreneurship and Innovation Summit in Nairobi, Wachiuri said currently 80 per cent of residents in Nairobi are renting, with people and businesses shving away from owned properties.

"Nairobi residents should look for opportunities posed by high incomes and population in their country to grow wealth and revenue," he said.

A report by Cytonn Investments on real estate market and construction released in September, shows that developers and working space retailers have been eyeing Westlands, Kilimani, Karen, Ngong Road, Thika Road, Kiambu and Limuru Road, Mombasa Road and Eastlands as major retail nodes in Nairobi.

Over 20 notable local and international retailers have penetrated the Kenyan market within the last six years, including Carrefour, Yves Rocher, Shoprite and Miniso from France, South Africa and Japan, respectively.

Kenya's due debts, repayment cause for concern - Moody's

Equally exposed to costly debt financing are Armenia, Pakistan, Sri Lanka and Honduras





Global credit rating agency Moody's has named Kenya among countries that will struggle to repay international bonds which are fast matur-

In the latest analysis released on Wednesday, Moody's Investors Service said international bonds maturing starting next year will expose Kenya, Armenia, Hondurus, Pakistan and Sri Lanka to costly debt financing.

"Sri Lanka, Armenia, Pakistan in particular and to a lesser extent, Honduras and Kenya will prove the most exposed to more costly debt financing as their international sovereign bonds mature in 2019 and 2020," Moody's said.

The study titled 'Sovereigns-Frontier markets: Maturing international bonds contribute to exposure to financing risks' warned that if the situation persists, debt affordability for those countries will be weak-

Moody's report reviewed international bond issuance from frontier market governments, defined as governments with a rating of Ba1 or lower and relying on concessional financing for more than 40 per cent of their external financing needs.

This negative outlook on Kenya's debt repayment is likely to see Moody's lower Kenya's creditwor-

or lend at higher interest rates.

The firm maintained Kenya's credit scores at B2 stable. It allocated the country this score in February after putting its earlier score of B1 on downgrade review in October last year. Moody's report collaborates another one by World Bank that listed Kenva among 14 sub-Saharan countries that will struggle to pay their loans beyond 2021.

Goods tracking boosts tax for countries - report

MERCY GAKII / A study looking at the Kenyan export market found that tracking goods shipments not only increased tax revenues for the government, but also increased efficiency for businesses because of the reduced turn-around time for trucks.

The World Trade Report released last week titled 'The Future of World Trade: How digital technologies are transforming global commerce' found that digital tracking of shipment of goods increased tax revenues for the Kenyan government and also increased business efficiencies.

"Tracking of goods has increased efficiency because of the reduced turn-around time for trucks," part of the report by World Trade Organisation said. The report added that new technologies reduce trade costs by reducing transportation and storage costs, reducing time to transport and the uncertainty of delivery time as a result of better logistics.

It however faulted the poor infrastructure network in Africa, whose missing rail links and pot-holed roads deter the nations from benefitting from new technologies. The report adds that what happens at the border may increase prices of goods to final consumers, coupled with wasted time on the roads.

Investigate whereabouts of millions in Liberian cash – US

REUTERS/ The US Embassy in Liberia said on Wednesday it had asked forensic investigators to carry out a preliminary probe into the possible disappearance of \$100 million in newly printed notes in the nation.

The currency scandal has sparked outrage and confusion in Liberia, where the central bank has denied a report by the information minister that the cash – equivalent to about 5 per cent of gross domestic product – went missing over the past year. In late September, the government said it had sought US help in investigating the whereabouts of the cash.

Death toll from Nigeria floods hists 199, disaster agency says

REUTERS/ The death toll from floods across much of central and southern Nigeria has reached 199, the national disaster agency said on Wednesday, almost doubling the number of people killed from three weeks earlier. The almost annual floods, exacerbated by poor infrastructure and lack of planning to protect against inundation, are the worst since 2012, when at least 363 people died.

This year floods have hit one-third of Nigeria's 36 states since late August, affecting 1.92 million people and displacing over 560,000 of them, said the National Emergency Management Agency.

Hurricane Michael heads northeast, devastates in Florida

REUTERS/ Hurricane Michael, the third most powerful storm ever to strike the US mainland, headed northeast yesterday, weakened, but still set to soak Georgia and the Carolinas after devastating the Florida Panhandle.

A man was killed when a tree toppled onto his house in Florida and a girl died when debris fell into a home in Georgia, officials said and local media reported.

The Category 4 hurricane was the fiercest to hit Florida in 80 years when it came ashore on Wednesday, but its strength waned as it pushed into Georgia. Early yesterday, it was downgraded to a tropical storm, with top sustained winds diminishing to 60 miles per hour.

More than 700,000 homes and businesses were without power in Florida, Alabama and Georgia early yesterday. Thousands hunkered down in shelters overnight after fleeing their homes to escape the fast-approaching storm.

The storm, packing sustained winds that reached 155 miles per hour, clobbered communities across the Panhandle, toppling buildings, downing trees and power lines and turning streets into roof-high waterways, television footage showed.

EYEING YUAN STABILITY

China constricts capital outflows

Beijing has been gradually easing monetary and fiscal policy this year, as it seeks to steer economy through period of slowing domestic growth and declining stock markets

REUTERS/ China's latest attempts at restricting outward investment by its residents show just how nervous policymakers in the world's second largest economy are about possible capital flight spurred by a broadening Sino-US trade war.

Beijing has been gradually easing monetary and fiscal policy this year, as it seeks to steer the economy through a period of slowing domestic growth and declining stock markets against the backdrop of escalating trade tensions with Washington.

While the Chinese central bank has tightened its grip on the currency, which is down about 10 per cent since the first salvos in the trade war were fired in March, it has refrained from direct intervention on a large scale to support the yuan, also known as the renminbi.

Unobtrusively, though, China has been moving to rein in currency outflows via the handful of overseas investment channels available to mainland investors.

"The last thing the government wants to see is capital stampeding out of China," said Tang Xiangbin, a foreign exchange analyst at China Minsheng Banking Corp.

Sources say approvals have been put on hold for a niche overseas investment product in Shanghai known as the Qualified Domestic Limited Partnership, or QDLP, scheme. The foreign exchange regulator has also not issued fresh quotas in the past three months under another overseas investment scheme,



the Qualified Domestic Institutional Investor, or QDII, data shows.

TACTIC 'HAS LIMITS'

So far the informal instructions, known as "window guidance", appear to be a precautionary move. There is hardly any sign of the heavy flight of capital seen previously during the 2015-16 market turmoil.

Yet analysts point to a host of factors that explain China's conservatism. While there are still heavy restrictions on how much of money Chinese businesses and retail investors can move overseas, Shanghai's bond and stock markets are more accessible to foreigners since 2015, thanks to Connect schemes that allow two-way flows between mainland exchanges and Hong Kong. Portfolio flows into China have grown and China's level of external debt is higher.

Meanwhile, the famed trade surplus the export powerhouse ran with the rest of the world has been shrinking.

Victor Shih, an associate professor of political economy at the Univer-

sity of California, San Diego, says currency devaluation could be an attractive option for China to offset the impact of the trade war.

But he warned the tactic had limits, as it "could create a panic on the renminbi which becomes difficult to control".

While the yuan has weakened this year, it has fared better than currencies of other large emerging markets, such as Brazil and Indonesia, that have been hurt by rising US yields and outflows of risk-seeking portfolio flows.

RESIDENTS ATTACK HEALTH WORKERS

Ebola response tightens in Congo as seven new cases confirmed – ministry

REUTERS/ Congolese authorities announced a ban on Wednesday on harbouring suspected Ebola patients and promised police protection for health workers at burials, in a bid to fight back against local resistance to efforts to combat the disease. Residents of eastern Congo have attacked health workers and refused to cooperate with government efforts to combat Ebola there, the country's second major outbreak of the disease this year, which is believed to have killed 118 people since July.

Ebola has spread to Beni, a city of several hundred thousand people where scores of people have been confirmed infected. The authorities worry that without the cooperation of the local population they will have difficulty containing it.

TWO-MAN CREW

Russian space rocket fails mid-air, crew lands safely

REUTERS/ The two-man US-Russian crew of a Soyuz spacecraft taking them to the orbiting International Space Station had to make a dramatic emergency landing in Kazakhstan yesterday when a rocket failed in mid-air.

US astronaut Nick Hague and Russian cosmonaut Alexei Ovchinin landed safely without harm and rescue crews who raced to locate them on the Kazakh steppe quickly linked up with them, NASA, the US space agency, and Russia's Roscosmos said.



Curbing road accidents is multi-agency duty

he death of 58 people in the Kericho road accident on Moi day has once again raised questions about road carnage in the country.

Government statistics show between January and October this year alone, 2,500 people have died in road accidents.

As expected, many people have been quick to blame the National Transport and Safety Authority and the police. This is the easy way out, yet there are many other actors, who should also take responsibility.

It is known police take bribes from public transport operators and allow them to break traffic rules. The Ethics and Anti–Corruption Commission should step up the fight against graft in this sector and charge the givers and takers of bribes.

The Kenya National Highways Authority, Kenya Urban Roads Authority and the Transport ministry all have roles to play in ensuring safety on the road.

The police should ensure the Traffic Act is fully enforced and violators charged in court.

And with the advancement of technology. we can now know road users' behaviour, the state of the vehicle and the speed at which it's being driven at any given time.

Authorities can also use technology to gather a person's driving behaviour data, which would then be reflected through high insurance premiums.

ANTI-GRAFT WAR IS SUCCEEDING

he revamped legal, policy and institutional framework over the last few years, has enhanced the fight against corruption and unethical conduct in the country.

The arrests and prosecutions of persons – senior government officials, businesspersons, and ordinary Kenyans alike - that have in the recent past led to hefty fines amounting to millions of shillings and mandatory jail terms has sent a strong message that being corrupt has dire consequences.

The cooperation being implemented in the criminal justice system aims to achieve a 100 per cent conviction rate in the future. It is an arduous task that requires all of us to work towards it. The EACC and the DPP work together to reduce the cycle time in investigation of cases and prosecution thereof. This cordial working relationship would result in many corruption suspects brought to book in record time.

Since 2013, the Commission completed 130 cases in courts leading to 67 convictions, 36 acquittals and 27 withdrawals. In particular, the 2017-18 financial year recorded 49 completed cases, resulting in 39 convictions and 10 acquittals. The convicted officials are senior public officials both in national and county governments. To our satisfaction, the anti-corruption war is getting better and bigger.

The commission has strengthened asset recovery mechanisms, which have provided positive results. For example, the EACC recovered the former mayor's house in Lavington, over 18 houses in Woodley Estate, the Grand Regency Hotel, Taifa Park in Kisumu, Uhuru Gardens in Mombasa, Karatina police land, Judiciary in Nairobi and Mombasa, Nyali beach access road and Pirates public beach, among others. In addition, there are 352 assets recovery cases in various courts in the country worth over Sh10.2 billion. The commission is certain it will recover all and revert to the government.

One of the key strategies the EACC has implemented is disruption of corruption networks to prevent graft before it occurs. In view of this, the commission has saved the government Sh20.7 billion over the last five years. This strategy has the benefit of curbing corruption before it happens, which is more cost

It's worth noting that the anti-graft agency is also implementing the Leadership and Integrity Act, 2012 (LIA), whose aim is to promote ethical standards in the

public service. It provides for the following: Limitations on the types, maximum value, storage and disposal and collection of gifts a state or public officer can receive and the procedure for the opening, maintaining and publicising of registers of conflict of interest; grounds and conditions for opening, registering, maintaining, controlling and closing bank accounts outside Kenya; lodging of complaints, investigation and disciplinary processes and mechanisms on the enforcement; development and commitment by state officers to specific leadership and integrity codes.

To this effect, 2,725 state officers have signed specific leadership and integrity codes and responsible Commissions are implementing the requirements of the regulations. These include Cabinet secretaries, Permanent secretaries, governors and their deputies, MCAs and county executives. Nine state officers have been charged with violation of LIA 2012. One state officer has been convicted of the charge and three petitions against state officers have been lodged in court with the aim of removing them from office.

The measures the commission has taken to prevent graft include systems reviews, advisory services promotion of standards and best practices, establishing and maintaining strategic partnerships and coalitions, public education and awareness creation.

Combating corruption and unethical conduct requires continuous flow of information to the public, which in turn guides policy efforts in preventing corruption. This information is multifaceted and diverse. The commission's National Ethics and Corruption Survey done last year indicates awareness level of the Commission has increased to 55.8 per cent, up from 41.2 per cent in 2015. Although this is impressive, about 40 per cent of Kenyans may still no be aware of the agency's presence. We will strive to use every available means to reach every Kenyan.

In the last five years, the commission has increased its presence from three to 10 regional offices to bring its services closer to the people. Further, the commission is in the process of opening three additional regional offices. It's my sincere hope the public will use this opportunity to report all corruption and unethical conduct cases.

The EACC has opened all fronts to combat corruption and unethical conduct and believes that the dragon of corruption will be slayed.

Large amounts of wildlife commodities have been seized in or en route to Asia

RESOURCES NEEDED TO END WILDLIFE TRADE

t the Illegal Wildlife Trade (IWT) conference on yesterday and today, global leaders and senior officials will gather in London to talk about the rampant trafficking of ivory, rhino horn and other wildlife products.

Will all the talking translate into action this time? Because the organised crime groups that profit from this multibillion-dollar market don't care about toothless commitments and pledges

The magnificent wildlife that supports Kenya's booming tourism industry is more valuable to criminals dead, hacked to pieces and packed into shipping containers heading to Asia than alive and roaming free across the savannah. The same is true throughout Africa for endangered rhinos, elephants, pangolins, big cats, turtles, fish, snakes and so many more.

The brains behind the trafficking of illegal wildlife products don't need to be too clever. It is simple supply and demand, and it can be extremely lucrative. Plus, even Kenya's comparatively strict wildlife laws are not a great deterrent in practice. You can get life imprisonment for smuggling cannabis but get off with a fine for possession of a game trophy.

On the supply side, there have been productive efforts in Kenya to combat poaching. On the demand side, large amounts of wildlife commodities have been seized in or en route to Asia and the Middle East. How many of these seizures have led to convictions in Kenva? Zero.

That is shameful, because porous land borders and impunity at ports have made Kenya the chosen route for illegal wildlife products from as far away as South Africa. Many obvious things we can do to stop wildlife trafficking are not being done efficiently or systematically due to a lack of resources and capacity on

Financial investigation, for example. Traffickers need to make payments to rent properties and shipping containers or book berths on vessels. Businesses can provide cover for moving large amounts of money and commodities without attracting attention. These leads can and should be pursued through smarter collaboration between banks and law enforcement.

Technology is another area that investigators and prosecutors need to embrace and understand. Criminals don't meet in darkened rooms these days — they use their phones to strike deals, agree sums and organise logistics. Not to mention those who give themselves away on social media by posting selfies and flaunting their wealth.

Thirdly, international collaboration desperately needs reinforcing. How many more traffickers would get locked up with better collaboration between law enforcement agencies in the countries of poaching, transit and destination?

Those of us who care about the destruction of Africa's rildlife — and the livelihoods that depend legally on it — are hoping that London's IWT conference will not simply be another opportunity for tea and a chat.

We want to see more resources channelled into joined-up activities that really make a difference on the ground. That means practical, expert mentoring to build capacity and streamline a disjointed intelligence

It means supporting local law enforcement agencies with whatever they need to more effectively investigate and prosecute wildlife crime. And ultimately, to prevent the devastation of our continent's endangered flora and fauna for personal gain.

END MOB 'JUSTICE' IN MOMBASA

n the last one week, Mombasa has reported at least four cases of mob lynching of suspects. The incidents were reported to have happened in broad daylight, as the public descended on suspects believed to be members of criminal gangs operating within Mombasa estates

Two of those killed were stoned to death, while one was burnt beyond recognition. The fourth suspect is believed to have suffered fatal injuries caused by blunt objects. In reporting these cases, the police and the public referred to them as mob 'justice'. However, in the case of Mombasa, it's neither mobdriven nor is it justice. It is vigilante groups targeting specific individuals and executing the heinous crime of murder in the name of 'justice'. The actions can only be equated to the unruly, irresponsible and reckless actions of a few individuals in society bent on

flagrantly violating the fundamental right to life guaranteed by the Constitution of Kenya.

In one of the incidents, the victim was a KCSE exam candidate, who had just left his home to go for tuition. According to the mother, soon after the son left, she received **FAMILIES AND THE** a call from a neighbour, informing her that her son was being attacked by a mob. She rushed outside, only to find a vigilante group administering a thorough beating to her son and his friend. The mother says the vigilante group tied a rope round his son's neck and dragged him to their office. Her pleading to the would-be murderers to

spare her son fell on deaf ears, as they proceeded with their actions to kill him. Her son died as she watched, in dismay and disbelief. It is the worst thing a mother could experience.

Article 50(2)(a) of the Constitution provides: "Every accused person has the right to be presumed innocent until the contrary is proved."

The key message for all to remember is that it is only the court that can declare a person guilty. Not the public, not the police. The killing of any person outside the confines of the law is illegal, murderous and unjustifiable. It is crucial that citizens be warned against taking the law into their hands. The lynching of suspects is not 'mob justice' but rather 'mob injustice'. We cannot have a situation where the public becomes the jurors and executioners, thus denying suspects their right to a fair trial. Proving guilt can never be done in the streets or police stations by vigilante groups or police death squads.

The increasing mob lynchings also indicate a breakdown of law and order. It is an indictment of the police, who are supposed to be the custodians of constabulary. When the people lose faith in the police and the justice system, they resort to other crude and unconventional means in search of that

When the mob, therefore, resorts to taking matters into their own hands, it means they have lost all trust and conviction in the security authorities.

In such a case, the police and others working in tandem with them have no moral authority or credibility before the HAKI AFRICA HAS citizens

However, in the case of Mombasa, it is not the mob that actually attacks and kills suspects: It is vigilante groups, as was reported in the case of the KCSE exam candidate. Members of the vigilante groups can be identified and pinpointed to the authorities for their arrest and prosecution for murder.

Haki Africa has received complaints from families of victims and the public in general of the unfolding situation of increased mob lynching. It is paramount

that the police immediately initiate investigations into the recent cases and bring the culprits to book.

No individual or members of vigilante groups, for that matter, should be allowed to kill any person out of suspicion. Whether it's the police or the public, they should arrest suspects and present them to court for legal processing.

Haki Africa, therefore, demands that the police arrest the situation by initiating investigations to ascertain the individuals behind the lynching, and ensure they are arrested and charged with murder. Kenya has laws and it is the duty of the police to ensure they are followed to

Husband blames surgeons for wife's botched breast surgery

Claims Wanza got poor care after operation, leading to fatal complications

The husband of June Wanza, the woman who died in June after breast enhancement surgery, says a bacterial infection could have eaten up her intestines following the operation.

Joseph Malupi accuses surgeons of negligence leading to perforation of the intestines during the breast surgery.

He says the management of Wanza at Nairobi Hospital was wanting and her death could have been avoided.

Mulupi's account is contained in demand letters sent to Surgeoderm Clinic and his testimony at the Kenya Medical Practitioners and Dentists Board, which is probing the death.

"Perforation of the intestines was negligent as you and your team were obligated to apply sufficient care and attention through the operation," he says in the letters sent in July and August.

"It is telling that post-operative care was inadequate as sufficient monitoring of the patient would have detected a complication arising from the lowering of the blood pressure, temperature and/or pulse rate suggesting bacterial infection eating up the artery tissues in the gut."

The letters have been attached to an affidavit filed in court by Surgeoderm director and plastic surgeon Prof Stanley Khainga in his effort to stop the probe by the KMPDB.

Wanja, 33, was an aspiring model and avid blogger. She had breast enlargement at the clinic on June 5 this year.

The enlargement involved a fat transfer, not an implant. She later developed complications and was rushed to Nairobi Hospital where she died after few days.

Khainga and two other Surgeoderm doctors exonerate themselves from her death, saying a doctor at Nairobi Hospital should be held responsible.

In his affidavit, Khainga says Nairobi Hospital received Wanza in stable condition but it was Dr Reuben Okioma who injured Wanza's neck at the hospital, causing the injuries that led to her death.

He says after the neck veins were punctured, a blood gushed into Wanza's lungs and stomach.

She suffered hypovolemic shock, cardiac arrest and died, he said. Hypovolemic shock occurs when the body loses more than 20 per cent of the blood or fluid supply.

The loss makes it impossible for the heart to pump sufficient blood. Organ failure occurs.

The account is supported by Surgeoderm's trainee plastic surgeon Martin Ajujo and anaesthesiologist Evans Cherono. Khainga's claim is supported by results of a post-mortem performed by Daniel Zuriel.

The three doctors say they fear KMPDB will blame them for Wanza's death yet "it is Dr Reuben Okioma who injured the neck vessels of the patient, causing the injuries that led to her death."

(+) KHAINGA SAYS BOARD IS BIASED

The medical board investigating Wanza's death has not yet asked Dr Reuben Okioma to record a statement. "All indications are we'll be blamed because Okioma and the Nairobi Hospital have been exempted from investigations, despite Wanza dying in their hands," Prof Khainga says in his affidavit. Wanza underwent the procedure at his clinic.

TRAINING IN KIAMBU

Senegal farmers learn to raise kuku kienyeji

GEOFFREY KIBISU/Senegalese farmers are in the country to learn how to stock improved kuku kienyeji.

The farmers are undergoing training at the Muguga-based Korea Project on International Agriculture (Kopia) in Limuru. Kopia director Choong-Hoe Kim yesterday said the research centre is well equipped to host trainees for a short course.

The farmers, mostly from rural areas of Senegal, travelled with an interpreter because they neither speak English nor French which is the official language in the West African country. The interpreter, Couta Camara, said they only understand Wolof. "That has slowed down the learning because the Kenyan farmers are making presentations in English," Camara said.

A majority of Senegal's 15 million people are farmers. The group that travelled to Kenya are expected to start poultry farming upon return. Most of them are women.

"Most of us are from rural areas where poverty is preva-

lent. We will acquire the skills to start kuku kienyeji rearing because the breed matures quickly," team leader Mamadou Bocar said.

The team yesterday toured the Mwea Irrigation Scheme in Kirinyaga. They found kuku kienyeji that matures early, has high meat volume and reliable egg production.

Kim said farmers from nearby Karai and Ndeiya villages have benefited from the project, including those from Mbiyuni in Machakos county.

"This project has economically empowered women through rearing the improved kuku kienyeji breed, which is in high demand. A rooster retails at Sh1,500 and that is just six months after hatching," Kim said.

Extension officer Hameth Sadji said he accompanied the farmers to ensure whatever is learnt on the trip will be replicated back home. The farmers will return to Senegal next week with eggs for hatching.

Maraga launches mediation to reduce backlog of cases

CJ says land disputes involving relatives can be resolved out of court

The Judiciary has launched an outof-court mediation process to reduce the backlog of cases.

Court Annexed Mediation will be coarried out under supervision of the court, with a mediator appointed by the Judiciary.

Speaking in Nyeri on Thursday, Chief Justice David Maraga said the Judiciary was ready to partner with county governments for a successful mediation.

"We're going to partner with county governments to get trained mediators," Maraga said. The CJ said land and inheritance cases account for a majority of disputes that have dragged on in courts, but they can be solved through mediation.

He said the cases mostly involve relatives who can resolved their disagreements through mediation. The CJ said there was no need for such cases to go to court and drag on for years. "We want to put a stop to that. We want to refer most of those disputes to Court Annexed Mediation where we have men and women of integrity to bring the people together," Maraga said.

He said mediation will create a win-win situation to enable families to remain together. Brothers and sisters should not be divided because of disagreements in sharing resources, he said.

LACK OF PERSONNEL

Maraga reiterated the Judiciary's commitment to clear cases that have dragged for more than five years. Some of the cases involve huges sums of money that ought to be released to the economy, he said.

"We are doing all we can to clear them and we require county governments' assistance for some cases which involve their people. We have to clear them," the CJ said.

He said a case should not take more than three years.

The Judiciary will involve county governments in drawing up buildings plans and construction designs. Maraga asked the county administrations to visit construction sites and give their input.

Maraga said many land cases were pending and promised to have them cleared

"The challenge is that we do not have enough personnel. Ideally, we should have like two judges in every county dealing with land matters but our numbers can't allow that," he said.

He said the Land Disputes Tribunal set up by the government was not properly run and had to be abolished. The CJ said cases like boundary disputes can be dealt with in villages.

Don't gamble away your tea bonus, official warns

ALICE WAITHERA/ Tea farmers have been urged to shun gambling and wisely invest their earnings ahead of an expected boom in two weeks.

The farmers are expected to get their bonus payments before the end of the month. Murang'a county commissioner John Elungata on Wednesday said operators of illegal gambling machines have hidden them as they wait to cash in on the boom.

The official said farmers should be careful and remember that their earnings are annual. Elungata said chiefs who condone gambling risk being sacked.

"I have noted that some administrators are very reluctant to fight gambling in their areas but we will deal with them and get on board those willing to work," Elungata said.

The official who spoke in Kangema said the administrators were under strict instructions to get rid of gambling machines that have ruined families financially.

He said fewer machines had been confiscated in Kangema subcounty compared to other areas yet Kangema is known to have numerous betting spots.

Elungata said police have been instructed to arrest operators of betting machines together with their customers.

"We know they put the machines in hidden dens where people bet under the cover of darkness. They are trying to be smart but they'll know we're smarter," Elungata said.

More than 400 gambling machines have been destroyed in Murang'a since January when a crackdown was launched. Some traders went to court to challenge the directive by the government.

Elungata said the gambling dens have directly destroyed the lives of many youths who are introduced to drugs and inducted into criminal gangs.

"Some of the traders have also been targeting schoolgoing children to introduce themto drugs," he said.

All bars found with gambling machines have been closed down. Elungata warned students against gambling, saying it tempts them to steal from their parents.

The official said they will destroy betting machines impounded. He called on residents to continue volunteering information to police.

Chewing miraa making Boni men impotent, elders warn

They said miraa chewing is on the rise and their population is dwindling as birth rates have dropped. They want miraa banned so the community does not go extinct. Kiangwe, Basuba and Bodhei Junction in Lamu East are worst hit, they said. Chief Yusuf Nuri said he will seek to have miraa banned from their villages. "Women complain that men don't take care of them. You can hardly see a pregnant woman or a baby," he said.

Msambweni deputy commissioner Ronald Enyakasi yesterday said they will also equip the riders with skills on security because they are exposed to criminals. "The training is one way of providing riders with relevant skills on handling criminals before police reach the scene. It'll enhance a mutual relationship between them and security officers," he said. He said the riders know many routes and would help police to tackle crime. Matuga deputy commissioner Isaac Keter said some riders are used to abet crime, hence the need to have the initiative. Kwale peace committee chairman Shariff Hajj said they had engaged Matuga and Msambweni riders.

TO BE KEPT IN MUSEUM

Researchers to probe death of whale shark

CHARISUCHE/ Researchers are investigating the death of a male whale shark found on the shores of Indian Ocean in Diani, Kwale, on Wednesday.

The 3.6-metre fish was found stranded near the shore before it died. Lilian Ndauri of the Kenya Marine and Fisheries Research Institute yesterday said it might have come to the reef, which is shallow, after being pushed by strong waves.

"This situation can only happen if the animal was hurt and couldn't swim in deep sees, or ate something poisonous. We've yet to establish the cause of its death," she said.

Ndauri added that it might have fed on microplastics. "Incidents of big fish dying do happen rarely. We'll take DNA samples to do research and find out more on the exact specie and keep it at the museum as a specimen to get an analysis," she added.

Peter Musembi said the whale shark wasn't a big one and weighed only 1.2 tonnes. "Such animals are upto 18 metres in length," he said.

Last month, a sperm whale was found dead at the shores of the Indian Ocean on Zote Beach, Kwale. Residents cut huge chunks of the mammal for food.

CHEMBE KIBABAMUCHE SCHEME

Watamu squatters accuse NLC of favouring tycoons

Hold protests against planned eviction after they missed out on allocation





Hundreds of squatters in the controversial Chembe Kibabamuche Settlement Scheme yesterday held a peaceful protest against planned eviction.

The area in Watamu, Kilifi, has 440 parcels. On Tuesday, National Land Commission boss Abigael Mbagaya said they are done with the scheme. She said 90 per cent of the land was cleared, a caveat removed and a Gazette notice issued on July 17.

The NLC chairperson said they would soon issue a notice of demolition to evict squatters who invaded private or public land.

"Invading private land without authority of the owner cannot make you the owner. Even if you build a flat it will be demolished," he said.

The squatters have, however, maintained they will stay put.

Yesterday, they said they had been denied the right to own land. They marched in their numbers, young and old, carrying placards and twigs

along the Jacaranda route. They said they had lived on the land for more than three decades and deserved to own parts of it.

The squatters said they were not satisfied with the NLC report, which allocated parcels to only those with titles. "We say no to madam NLC chair Abigael. Stop calling us squatters, Noooo!" one placard read.

Another one added, "Same NLC with different rulings, stop wasting government money, stop killing our future."

They accused the commission of siding with absentee landowners and grabbers. Chembe Kibabamuche is one of the controversial government schemes. At some point, a caveat was placed over some parts. It was later lifted.

The squatters said their attempt to seek audience with the NLC over the land were unsuccessful. Tycoons benefitted from it irregularly, they said. Last year, however, the NLC verified ownership and conducted public hearings.

The residents want the issue revisited. Majengo Lughanje, 85, was evicted and his house demolished

by a person who staked claim of the parcel. He said he was issued a notice to vacate the land after staying there for more than 35 years.

"I want my land and coconut trees. I planted trees and someone came recently to claim ownership. I was evicted and can't even eat the fruits of my labour," Lughanje said.

Hamisi Kombe said they are demeaned because of the squatter tag, while the rich are enjoying their "sweat after we developed roads".

Benjamin Kimera said it was unfortunate that they are being told to leave after investing in the area. There are roads, electricity and water supply courtesy of the "so-called squatters", he said.

Samuel Shariff said they live in fear as they could be evicted any time. He said their lives would be disrupted. Mama Ngangari urged President Uhuru Kenyatta and NASA chief Raila Odinga to intervene and stop their evictions.

EX-SOLDIERS WERE ACQUITTED

Appeal Court to hear state appeal

MALEMBA MKONGO/ The Court of Appeal in Mombasa has said it has powers to hear an appeal by the state against 25 former KDF soldiers.

The ex-soldiers were acquitted by the High Court in 2015 after the Mtongwe-based Court Martial sentenced them to life imprisonment. They were charged with deserting the military in 2007 and 2008, a time when the country needed their services. However, Judge Martin Muya said the country was not in a war when they left for greener pastures. He set them free. The state, through the DPP, appealed, but the soldiers said the three-judge bench did not have jurisdiction to hear the case. Yesterday, the court said they were freed by the High Court, not the Court Martial, hence, it has powers to hear the case.

Police were on standby around the 60-acre parcel to deal with those who would resist. Tension was high in the morning. The squatters say Hussein Dairy Farm allocated them the land in the 1990s. But the sacco says it bought it in 2011 from the farm for Sh300 million. The squatters had asked for 14 days to file a counter case to stop the reconstruction, but the security apparatus and the sacco warned against disobeying court orders. The reconstruction ended peacefully. Sacco chairman Ken Sungu said they incurred Sh20 million losses to destruction. "It'll cost us Sh20 million to rebuild this wall. The other time it cost us a similar amount to put it up," he said at the site.

Lorry offloading suspected stolen goods seized in Makindu

MUTUA KAMETI/ Detectives in Makindu on Wednesday impounded a lorry that was offloading office equipment at Kibarani shopping centre. The vehicle had allegedly been hijacked in Voi.

Makueni police commander Joseph Napeiyan said the equipment included water dispensers, refrigerators and electronics. They are suspected to have been stolen.

He told the Star the driver of the lorry who was headed to Nairobi is being treated in Voi. Police arrested the person who was in control of the lorry when it was impounded.

The police boss said they received reports at 4am about the lorry. It was found offloading the equipment outside a shop at 5am. He said the driver claimed he was ambushed by a gang near Voi when he was inspecting the tyres. Police are investigating whether the driver is part of the gang.

Sabaki residents protest against 'blocking of road' by developer

GEORGE OWITI/ A contractor was forced to flee on Wednesday after more than 500 residents stormed a construction site in Sabaki, Machakos county.

They were demonstrating against a private developer whom they accused of blocking an access road to Sabaki estate. Carrying twigs and chanting "punda amechoka", the demonstrators pulled down part of a perimeter wall that was under construction. They claimed the wall was on the road.

They said the developer started blocking the road on Monday. Sabaki Residents Association's chairman Muradha Kariuki said they would keep a vigil to ensure the road remains open. "We have been using the road for 10 years," Kariuki said. He said on checking on the original map, they realised there is a 20-metre-access road on the land.

Embu on high cholera alert, three in hospital

REUBEN GITHINJI/Two people in Embu county have tested positive for cholera.

One patient is admitted at the Embu Level 5 Teaching and Referral Hospital in an isolation room. The other was treated and discharged on Wednesday.

Embu Health executive Jamleck Muturi said the two men who tested positive come from Embakasi, Tassia, in Nairobi, where they consumed 'mutura' before they travelled to Embu.

He said two other patients, a father and daughter from Runyenjes, are being treated for cholera-like symptoms. The executive said the father and daughter are being treated at Kyeni Mission Hospital and Runyenjes Hospital, respectively. Muturi said medics are waiting for the tests of samples from the patients to ascertain if they have cholera. He said the health department is on high alert to prevent spread of the disease.

Muturi urged residents to practice good hygiene, boil drinking water and wash their hands after using the toilet. He said public health departments officers have been instructed to inspect all eateries to ensure the food is clean and safe.

Muturi said there will be a crackdown on food hawking. He said the county government on Wednesday organised a free medical camp at Embu Municipal stadium to educate residents about cholera and offer free treatment for other illnesses.

Ask CS Kiunjuri where miraa money is, Kiraitu urges MPs

Says he isn't using miraa funds to distribute avocado, macadamia seedlings

Meru governor Kiraitu Murungi has distanced himself from Agriculture CS Mwangi Kiunjuri remarks that they agreed to allocate part of Sh2.2 billion miraa funds to macadamia and avocado seedlings.

He said last Friday he distributed 200,000 macadamia and 200,000 avocado seedlings to farmers because they have ready market in China and Europe.

"I have not received or spent a coin from the national government miraa fund. We have met with CS Kiunjuri several times but we never agreed that I would use any shilling from the miraa money," Kiraitu said.

He said he aims to distribute one million avocado and macadamia seedlings for each crop. The aim is diversification.

"The whole budget for the project is Sh90 million. No one is coerced to plant," Kiraitu said. He said if the national government wants to promote avocado and macadamia farming using their miraa funds, it will do so as the national government, not the county government.

Kiraitu asked Meru MPs to summon Kiunjuri in Parliament to explain where the miraa money is.

"I never told anyone to uproot miraa to plant macadamia or avocado. I have only urged farmers to practice intercropping," the governor said.

Kiunjuri had said the ministry and Kiraitu's administration were in agreement the miraa funds would go towards buying macadamia and avocado seedlings to help farmers diversify crops.

"I have the miraa money and we have agreed with the Meru governor to allocate the biggest share of the funds in provision of avocado and macadamia seedlings this rainy season," the CS had said at Gitoro ASK Showground during the Meru Dairy Union Farmer's field day.

The announcement led to public outrage, splitting of MCAs and condemnation by MPs.

Three Meru MPs demanded clarity from Kiraitu and Kiunjuri.

Tigania East MP Gichunge Kabeabea, his Igembe North counterpart Maoka Maore and East Africa Assembly MP Mpuru Aburi said there will be negative consequences if the money is diverted to other uses.

Maore said the miraa money was set aside to improve the crop, provide water, build sheds, seek markets and carry out research "The truth of the matter is the Meru government has its own agriculture budget. Let the county use it for purchasing avocado and macadamia, not miraa funds," Maore said.

Kabeabea said the funds should be used to develop new miraa markets. Aburi said Sh1 billion for miraa was factored into the 2016-17 budget and an additional Sh1.2 billion later to cushion miraa farmers from effects of the European markets ban.

Meru residents urged to go for cancer tests

GERALD MUTETHIA/A palliative cancer care centre in partnership with researchers, doctors and institutions of higher learning are conducting holistic research to establish the main causes of cancer prevalence in Meru.

Meru Hospice director Gladys Mucee told the Star the pilot study was conducted in June, but she was not at liberty to release the findings. She said concrete research needs funding.

Mucee said the challenge of not having an oncologist, late cancer detection and lack of chemotherapy have severely undermined the war on the disease.

She urged residents, especially men, to go for prostate cancer screening. Mucee said free screening will be provided near Mwendantu in North Imenti, Meru town, on Saturday. Most men, she said, are afraid to go for screening.

Mucee said the most prevalent cancers are those of the stomach, oesophagus, colon, breast, cervix and prostate. "We have raised concerns with Governor Kiraitu Murungi who has been so helpful, opening a cancer centre and having an oncologist," Mucee said.

She said they are worried over effects of cancer on young children. She urged everyone in Meru to donate Sh10 each.

Traders count losses in Garissa demolitions

Garissa county commissioner's compound hit even as some town residents say demolitions needed for town expansion



Garissa town businessmen are complaining about demolition of structures encroaching on the Kismayu road reserve.

The Kenya National Highways Authority yesterday started pulling down buildings. It demolished or partly brought down hotels, electrical shops, kiosks, car wash businesses, eateries and retail shops.

Traders who were alerted of the demolition that started atabout 3am rushed to salvage property but it was too late for some.

Several police officers guarded the bulldozer that was bringing down

perimeter walls, parts of buildings and structures along the busy road.

Power supply to buildings along and adjacent to the road reserve was disrupted during the demolition.

The county commissioner's compound was among those affected. KeNHA issued a notice two months ago to all business people who have erected buildings on the road reserve. They were told to bring them down but some ignoredit.

The demolition is expected to extend to Modikam about 10km from Garissa town. The bulldozer attacked Getune Primary School, bringing down the gate and part of the bujilding.

Proprietors who were interviewed said the exercise was done selectively as other premises along the same reserve were left out. Mohamud Maalim who owns a petrol station said his water reservoir was destroyed "yet it was not near the road reserve".

Hassan Abdinoor, an elder, said the expansion of the town was long overdue because estates cannot be accessed in emergencies. He urged KeNHA to carry on and bring order to one of the fastest growing towns in the country.



Nyong'o loses case in Sh200m estate

Nephews win as Kisumu High Court orders governor to include them as beneficiaries of Sh200m estate

Kisumu governor Anyang' Nyong'o yesterday lost a family estate battle after a court ordered that his nephews and nieces be included as beneficiaries of his father's Sh200 million estate.

Nyong'o had wanted them excluded.

A Kisumu court revoked the letters of administration and certificate of confirmation of the grant of the estate and instead appointed Kenneth Odhiambo Okuthe as a co- administrator of the estate, jointly with Nyong'o and his sister Risper Nyagoy. The governor's father Hesbon Shimei died on November 10, 2006, without a will.

The governor's two nephews, Okuthe and Geoffrey Omondi, sued him and his sister Risper for leaving out some relatives in the list of beneficiaries of the estate. They said the governor and his sister were made the administrators of the estate af-

ter the local chief certified the two and their mother as the true beneficiaries.

They accused the two of neglecting the children of Margaret Awuor and Judith Nyong'o, who were daughters of Shimei. Omondi is the eldest son of Judith, now deceased. Upon her death, she left Omondi and another sibling, Fiona Atieno. The applicants are accusing Nyong'o and Nyagoy of concealing important information on confirmation of the grant and not accounting for the estate.

However, yesterday justice Tripsisa Cherere said she was satisfied that the applicants were beneficiaries and are entitled to the estate of the deceased.

Cherere noted the children of Margaret Awuor and Judith Nyong'o are entitled to inherit their grandfather's estate as the deceased mothers were daughters of Shimei. Whether the applicant made a case on the revocation of the certificate of grant, the judge said there was overwhelming evidence to revoke the certificate of confirmation of the grant.

Kapseret legislator, a close ally of DP Ruto, says he and other leaders will provide political protection against removal of the buildings said to be on riparian land and road reserves. Twenty-seven structures targeted

Political leaders in Uasin Gishu county will not allow demolition of illegally built houses in Eldoret town and its environs, Kapseret MP Oscar Sudi has said.

He said the multi-agency team carrying out the demolition must consult local leaders before bringing down any structures that have been declared unsafe.

Sudi said 27 structures built on riparian land and wetlands are targeted. He urged the government to proceed with caution.

Sudi, a close ally of Deputy President William Ruto, told owners of the targeted buildings not to worry, as he and other leaders will give the property "political protection" against demolition.

The MP spoke in Eldorert on Wednesday during a funds drive to offset the medical bills of prominent businessman Benjamin Kiplimo who died in a road crash.

Governor Jackson Mandago and his Nandi counterpart Stephen Sang were present.

The Kapseret MP told the multi-agency team to respect the sanctity of title deeds and stop flattening buildings constructed on parcels of land acquired through the correct procedures.

"As elected leaders in the county, we shall not allow any of the buildings listed as unsafe to be flattened without our goodwill and support. He said they will not allow demoli-

tions like those that "befell" owners in Nairobi.

He faulted the state for "ambushing" owners of the structures with demolition notices, instead of giving them enough time.

The National Environmental Management Authority (Nema) has defended the planned demolition of structures in Uasin Gishu county. The authority said buildings on their radar include those built along river Sosiani and on wetlands.

In August, 10 structures were pulled down in Eldoret. They were said to be standing on a road reserve.

Uasin Gishu Industrialisation executive Emily Kogos said the buildings will be pulled down. She said owners of the structures have been given notices for demolition. Buildings on road reserves are being demolished.

The county plans to use Sh300 million for re-planning Eldoret to position itself for city status.

Former Uasin Gishu governor aspirant Bundotich Kiprop, popularly known as Buzeki, has opposed demolitions in Nairobi and elsewhere.

-He said the government should negotiate with owners to come up with amicable solutions, instead of ruining investments. The businessman said government officials approved some of the buildings and destruction would not be the best way to solve the problem.

He said those who approved the buildings should be punished.

MATHEWS NDANY! / Eight counties in the North Rift lose more than Sh500 million annually due to frequent outbreaks of livestock diseases.

Governors are planning a joint vaccination drive covering Trans Nzoia, Uasin Gishu, Nandi, West Pokot, Elgeyo Marakwet, Baringo and Turkana.

The counties have been unable to separately control the outbreak of especially foot and mouth disease.

Trans Nzoia deputy governor Stanley Tarus said the diseases will only be eradicated through joint efforts. He spoke to farmers in Kitale on Wednesday.


Architect wants Sh11 million from pyrethrum board for building work

RITA DAMARY /An architect hired by the Pyrethrum Board of Kenya to build a godown in 2001 is seeking over Sh11 million. Julius Matasyo sued the board for the debt in 2005.

Matasyo says PBK paid him Sh400, 000 in December 2001 for work done. The balance allegedly remained unpaid. On April 27, 2012 a judgment was issued in favor of Matasyo against PBK for the sum of Sh4.8M. But the money and accrued interest has not been paid. PBK was dissatisfied with the judgment and obtained an order of stay of execution.

The architect hired auctioneers who impounded seven vehicles belonging to PBK. Acting PBK manager Paul Lolweritoi asked the court for time to propose on how to pay the debt. Judge Justice Joel Ngugi allowed application.







Kenya, Ghana and Ethiopia wait as Caf delay decision on Sierra Leone's fate

Hopefuls to qualify from a tricky group that includes Harambee Stars, four-time continental champions Ghana and un-fancied Ethiopia will have to hold their breath a little longer on the fate of Sierra Leone.

This follows Caf revelation late on Wednesday that they will not make a decision on their suspension at least until December.

Ghana were due to face Sierra Leone yesterday and again on Monday but with the games shelved, a Caf spokesman said it would not allow the matches to be played later, even if the ban was lifted.

However, he said they would delay the decision on whether to award Ghana a 3-0 victory in each match or disqualify Sierra Leone, in which case their results would be expunged and three teams would be left in the group, with the top finishers advancing to next year's finals.

Stars would be the biggest beneficiaries should the Sierra Leone results be removed as the West African nation had beaten them 2-1 in the opening group game. That would obviously be refuted by the national team as it would seem a case of schadenfreude on a sporting opponent.

However, with a chance of reaching a first Africa Cup of Nations final in 15 years on the line, Kenyans who were due to fly back last evening, would welcome the move having lost to the west Africans. Should that be the case, both Ethiopia who beat Sierra and Ghana in particular will be downcast.

The first proposal will be received with glee in Accra and Kumasi as it would give the Black Stars six points without kicking a ball particularly after their loss to

Kenya and a final day decider due in March. As it stands, without factoring in the suspension ramifications, Kenya lead the group with four points same as Ethiopia both having played three times after Wednesday goal-less but entertaining stalemate.

Ghana and Sierra Leone have a win each from two matches. Kenyans are expected to move straight to their Utalii Hotel base once they land from Ethiopia.

The Caf spokesman told Reuters that depending on if and when the ban was lifted, Sierra Leone could play their last two qualifiers against Kenya in November and Ethiopia in March.

On Tuesday, Fifa rejected a petition from the country to lift the ban because they did not meet a deadline to reinstate ousted Sierra Leone FA president Isha Johansen, who is accused of corruption by government officials.

Russia players Kokorin, Mamayev detained by police over attacks

MOSCOW / Russian police said have opened a criminal investigation and detained Russia internationals Alexander Kokorin and Pavel Mamayev, who are accused of carrying out violent attacks in central Moscow.

The attacks, allegedly perpetrated by Zenit St Petersburg forward Kokorin and Krasnodar midfielder Mamayev on Monday, were captured on CCTV and prompted widespread outrage among ordinary Russians as well as reaction from the Kremlin.

Footage, which has been circulated widely by the Russian media, shows a man being kicked and punched in the street by a group of people said to include the two footballers and another incident in which two civil servants appeared to be assaulted in a cafe. Mamayev and Kokorin have declined to comment.

The two players were summoned by police for questioning on Wednesday and told that if they did not appear then nationwide search warrants would be issued. Police said both players had turned up and had been detained over charges of hooliganism.

BY IAN HERBERT / Cristiano Ronaldo's new Las Vegas lawyer confirmed the player had struck a financial deal with Kathryn Mayorga, the woman who accuses the Portuguese of rape, but insisted documents about the case had been forged in a deliberate attempt to defame him.

Peter Christiansen said there was nothing suspicious about Ronaldo paying Ms Mayorga \$350,000 (£266,000) to keep quiet about what the player claims was consensual sex at a Las Vegas hotel, in 2009.

'This settlement is by no means a confession of guilt," the lawyer said. He insisted Ronaldo had paid up to quash 'outrageous allegations' which were an attempt to 'destroy a reputation that has been built upon hard work, athleticism, and honour.

He said Ronaldo, 33, who denies the allegations, would sue German media outlet Der Spiegel over the publication of documents secured from the whistle-blowing platform, Football Leaks — which has revealed hundreds of contracts, third party ownership deals and alleged tax evasion strategies.

Christiansen added: "In 2015, dozens of entities, including law firms... were hacked and their electronic data was stolen and captured by a cyber criminal.

"This hacker attempted to sell this data, and one media outlet has now irresponsibly published the stolen documents, significant portions of which were altered and/or completely fabricated.'

Eyes on Sterling

Real 'monitoring Raheem's contract situation' at Man City as he enters the final two years

BY GLEN WILLIAMS / Real Madrid are keeping close tabs on Raheem Sterling's contract situation at Manchester City.

The 23-year-old has less than two years left on his current deal and has previously said he would be open to discussing a move away from the Etihad.

"It would be nice to play abroad," Sterling said last year. "It would be a great experience. Spain's attractive. Anywhere the weather is nice really."

And, according to ESPN, there is willingness from both parties for Sterling to sign a new deal at the club— but Real Madrid are closely monitoring the state of play.

Sterling put pen to paper on five-year contract back in 2015 when he moved from Liverpool for £49million.

But as yet there has been no sign of a new deal for the England international, despite the likes of Kevin De Bruyne and Sergio Aguero penning extensions in the last year.

City boss Pep Guardiola, however, has waxed lyrical about the player and, back in August, said the club will do their best to keep him. "We are delighted with him

and would like Raheem to stay," Guardiola said this summer.

"We'll do our effort to make him feel we count on him. And we count on him. We arrived after a difficult season (two years ago) and I told him I want to help him and would like him to be happy.

"In the end, the agents may not have agreements and that may not happen. But he knows and his agent knows we like him and want him a lot."

As yet, there has been no contact between the clubs regarding the player. However, should City allow Sterling's contract to run down further, the La Liga giants will certainly have their interest piqued.

Elsewhere, Everton can learn

from the mistakes of rivals in building a new stadium to help bridge the gap to the leading Premier League teams, their finance chief said.

The Merseyside outfit last year formally agreed a 200-year land lease at the proposed Bramley Moore Dock site. Everton have played at their distinctive Goodison Park ground since 1892, but with a capacity of only 40,000 the club struggles to compete with the match-day income of rivals.

Yet some top-flight teams have experienced difficulty moving to new homes. West Ham United have endured crowd trouble and disruption since their switch to the London Stadium in 2016.

Zabaleta calls for West Ham consistency after break

LONDON / West Ham United's patchy early form has cost them places in the Premier League table and although the club are not in a crisis they must strive to be more consistent, defender Pablo Zabaleta has said.

The London club, who began the campaign with four defeats, appeared to be back on track after victories over Everton and Manchester United on either side of a draw against Chelsea.

However, Manuel Pellegrini's side lost 1–0 to Brighton and Hove Albion last weekend which left them 15th in the standings with seven points from eight matches.

"OK, let's say the situation isn't a crisis but also it's not perfect. The most important thing we can learn from those games is to understand that to become a better team we need to improve our consistency," Zabaleta told the club's website.

"Those dropped points make the difference in the table. If we had three or four more, we'd be a few places higher, six or seven points from the relegation zone and just three or four points from the European positions."

West Ham, who spent most of their last two league campaigns struggling in the bottom half of the table, started poorly as they adapted to new manager Pellegrini's tactics.

The importance of Skipper's role has diminished

JUST WHERE HAVE ALL CAPTAIN MARVELS GONE IN MODERN GAME?

Petr Cech passed the captain's armband to Aaron Ramsey who wore it for a while then handed it to Mesut Ozil. Up in the Emirates Stadium stands, Frank McLintock scratched his head and wondered what had become of this prestigious office.

In Azerbaijan, four days later, Nacho Monreal led out Arsenal against Qarabag and in the second half it was Danny Welbeck. Against Fulham, on Sunday, Granit Xhaka had the honour. Six different players in three games. The official club captain Laurent Koscielny is injured.

"It seems anybody can take it—like it's a present," said McLintock. "For me, the great teams always had great captains. I don't know if that was just a British thing. Bobby Moore, Bryan Robson, Danny Blanchflower... not all the same style but all leaders.

"We'll probably never see these types again. As long as they're good players. Virgil van Dijk doesn't shout like Tommy Smith but he's a good player.'

McLintock, 78, belongs in company with great club captains of the past — with Billy Bremner, Roy Keane and Tony Adams. At Arsenal, manager Bertie Mee wanted the Glaswegian to be the first voice his players heard at half-time. Trailing 3-1 to Anderlecht after the first leg of the Fairs Cup final in 1970, McLintock's passionate speech inspired a fightback which clinched the trophy at Highbury and launched them towards the Double a year later.

In the FA Cup at Manchester City, he once conjured magic from Charlie George by inventing a tale about how City's flamboyant assistant manager Malcolm Allison really didn't rate him. "I told him Mal thought he was a bottler, a typical Cockney, all mouth and no trousers,' said McLintock. "I had to defuse it afterwards.

"Charlie scored twice and gave him a right mouthful. Poor Mal had no idea what was going on."

Arsenal's captaincy has been restless since Patrick Vieira's exit

in 2005. Manager Arsene Wenger seemed to use the role as a device to stop players leaving but it not work with Thierry Henry, Cesc Fabregas or Robin van Persie any more than it convinced William Gallas to embrace responsibility.

Others in the upper echelons of the Premier League appear equally unsure what to do with the role.

At Manchester United, Jose Mourinho stripped Paul Pogba of the vice-captaincy and captain Antonio Valencia hit the 'like' button on a social media message calling for his manager to be fired.

Michael Carrick was named captain when Wayne Rooney left but was mostly injured and Valencia, who took over, is not always in

the team. Others have also led out the team, including Ashley Young and Chris Smalling. A strong captain might have helped Mourinho. At Chelsea, where John Terry was captain for years, Cesar Azpilicueta has had the armband because Gary Cahill is out of favour but there is a suspicion the job is Eden Hazard's if he commits to a new contract.

Manager Maurizio Sarri swerves the question and says he must first talk to the board and the players about his plans — hardly a ringing endorsement for Azpilicueta.

"I don't think it matters any more," said Terry Butcher, former captain of Ipswich, Rangers and England. "It doesn't have the same aura. The higher you go, the less the captain plays a role. There are exceptions, you see it more in the lower leagues, but it's lost some of its sparkle.

"It's generally given to the best player and the best player is not the best leader. That's diluting the role. Ultimately, the team can run out in any order and decide among themselves who does the toss. "Maybe there are not enough leaders. People used to point fingers and get you going. Bryan Robson would have a go at me on a regular basis and it sharpened me up. I don't see it in the Premier League. Players make a mistake and no-one's shouting, driving people. They walk away.

"Maybe they think they'll still play next week. We've lost a lot of things but you have to say the standard has improved enormously."

Glenn Hoddle wanted Alan Shearer as his England captain. He wanted the best player leading the team just as Diego Maradona led out Argentina. This season, Lionel Messi is the captain of Barcelona.

Gareth Southgate, the current England boss, was a thoughtful captain as a player and he took time before opting for Harry Kane. The lionhearted leader that blood-soaked Butcher came to embody was a British creation since eroded by the internationalism of the Premier League and the demand from coaches for more refined footballers.

Different cultures and sports science have meant fewer paint-balling expeditions and booze-ups to organise. Increasingly, there are headphones and iPads or agents and entourages for company rather than a band of brothers. There may be tickets to organise, fines to administer and bonuses to discuss but player-liaison officers and translators help new signings settle and managers can now lean on armies of support staff.

In the no-excuses environment of modern elite football, players are spared all distractions. Yet at the same time the cult of the manager has flourished here.

The Premier League attracts the world's best coaches and most want to take complete control. If they are to fail they want to fail on their terms. Not yielding to accommodate a cult hero in an armband.

Personality captains such as Troy Deeney and Mark Noble have fought to regain their places at Watford and West Ham respectively.

ATHLETICS 138 KENYANS HAVE TESTED POSTIVE IN LAST 14 YEARS

Kalalei banned

Another Kenyan athlete handed four-year ban after testing positive for EPO

BY REUTERS / Kenyan marathon runner Samuel Kalalei (pictured), who won the Athens marathon last November, has been banned for four years after testing positive for blood-booster EPO, the Athletics Integrity Unit (AIU) has said.

Kalalei's urine sample, which was collected after the Rotterdam Marathon in April, had returned positive for EPO. The 23-year-old was provisionally suspended by AIU, the independent agency of world athletics ruling body IAAF, on June 4.

The AIU said that all of Kalalei's results since that event in the Netherlands would now stand disqualified. Kalalei had set a personal best time of two hours 10 minutes and 44 seconds to finish in seventh place.

Kenya's reputation as a dominant force in global middle and long-distance running has been tarnished in recent years by doping cases among their elite athletes.

Earlier this year, the AIU handed four-year doping bans to Kenyan long distance runners Eliud Magut and Suleiman Kipses Simotwo. Both had tested positive for Norandrosterone, a metabolite of the prohibited Nandrolone.

A World Anti-Doping Agency report said that between 2004 and Aug. 1, 2018, as many as 138 athletes from the east African nation had tested positive for prohibited substances, 113 of them during competitions.

Meanwhile, International Olympic Committee admitted nine new members but snubbed both soccer's Fifa and athletics' IAAF again as both have struggled with widespread corruption and doping scandals.

Greece, host of the first modern games, was also left out in the cold for the third year running, in the wake of bitter disputes there over control of the national Olympic committee.

Morinari Watanabe and Andrew Parsons, the heads of the international gymnastics federation FIG and International Paralympic Committee (IPC) respectively, were among those to join the committee. They were joined by Italian Olympic Committee President Giovanni Malago, whose country is bidding for the 2026 winter Games.

The other IOC inductees were senior national Olympic committee members Samira Ashgari from Afghanistan, Prince Jigyel Ugyen Wangchuck from Bhutan, Daina Gudzineviciute from Lithuania, Camilo Perez Lopez Moreira from Paraguay, Felicite Rwemarika from Rwanda and William Blick from Uganda.

While membership of the IOC for the heads of soccer and athletics, two of the world's largest federations, was seen as almost automatic for years, the committee did not propose Fifa President Gianni Infantino or IAAF President Sebastian Coe this time. Despite presiding over two of the most popular sports in the world, Fifa and the IAAF have been embroiled in a range of scandals in recent years. The IOC also snubbed Greece - host of the first modern Games - for the third year running, leaving it without a representative since 2015.

Belgian agent questioned in match-fixing investigation

BRUSSELS / Belgian investigators questioned the country's most influential soccer agent Mogi Bayat yesterday, a day after he and senior figures in Belgian football were detained on suspicion of financial fraud and possible match-fixing.

At the same time, a Belgian judge was deciding whether or not to charge some 25 people, including the coach of champions Club Bruges, the former general manager of Anderlecht, referees and other officials. Some could be kept in custody.

Belgian police raided 44 Belgian clubs and residences across the country on Wednesday, while a further 13 searches took place in France, Luxembourg, Cyprus, Montenegro, Serbia and Macedonia.

The lawyer of former Anderlecht general manager Herman Van Holsbeeck told broadcaster RTL that his client had been released on Wednesday after giving information about transfers and contracts.

Ivan Leko, the Croatian coach of Bruges, was still in custody, his lawyer said, after answering questions on Wednesday. Bruges are playing in Champions League Group A with Atletico Madrid, AS Monaco and Borussia Dortmund. Bayat, a high profile figure who has brokered a series of larger player transfers in the country, was facing questions yesterday, his lawyer said, while complaining about the force used to detain him at dawn on Wednesday.

Three months after the Belgian national side reached the World Cup semi-finals, the news indicating uncomfortably close ties between agents, soccer officials and referees dominated Belgian media. There was widespread speculation about which matches might have been fixed.

Many focused on an extraordinary end to the regular season in Belgium's top division, when Mechelen were relegated on a goal difference of one after they won their final match 2–0 while Eupen scored four goals in the last 20 minutes of their game to stay up.
